## What is the product?

Type: This Product is an investment company qualifying as UCITS Sub-fund in accordance with the UCITS law.

**Term:** This Product has no maturity date. The Sub-fund has been established for an indefinite period of time. The Board of Directors of the Investment Company is entitled to liquidate, merge or reposition the Product at any time unilaterally in case the Product can no longer be managed in the interest of the investors. The amount the investor will receive upon early termination may be less than the amount invested.

**Objectives:** This Sub-fund is actively managed without reference to any benchmark aiming to achieve capital appreciation over the long term. The Sub-fund promotes environmental, social and governance (ESG) characteristics (within the meaning of Article 8 of Regulation (EU) 2019/2088) through a combination of different portfolio management techniques. Details are available in the prospectus and the ESG website disclosure of the Sub-fund. The Sub-fund mainly invests, either directly or via Target Funds (incl. ETFs - Exchange Traded Funds) in equity and equity-type securities of issuers worldwide. The Sub-fund may invest up to 20% of its assets in China A-Shares. It invests without being limited to a specific currency, industrial sector, capitalization of the issuer or geographic scope; however investments in emerging markets will not predominately be represented. In order to achieve its objective, the Sub-fund can use derivative instruments to protect against movements in currencies and security prices and for efficient portfolio management. The investor can buy or sell shares on a daily basis (Luxembourg and Switzerland bank business days). This Share Class does not make regular distributions. The Sub-fund shall bear the costs of standard brokerage and bank charges incurred by the Sub-fund through securities transactions in relation to the portfolio.

**Intended Retail Investor:** This Product is intended for retail investors with sufficient knowledge and experience in collective investment schemes and similar products, an ability to bear an average investment loss, and a long-term investment horizon.
