What is the product?

Type: This Product is an investment company qualifying as UCITS Sub-fund in accordance with the UCITS law.

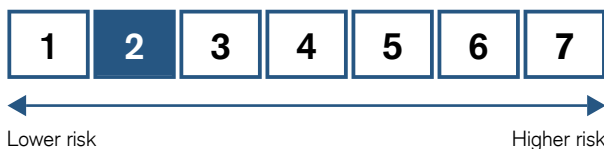
Term: This Product has no maturity date. The Sub-fund has been established for an indefinite period of time. The Board of Directors of the Investment Company is entitled to liquidate, merge or reposition the Product at any time unilaterally in case the Product can no longer be managed in the interest of the investors. The amount the investor will receive upon early termination may be less than the amount invested.

Objectives: The Sub-fund is actively managed without reference to any benchmark. The Sub-fund promotes environmental, social and governance (ESG) characteristics (within the meaning of Article 8 of Regulation (EU) 2019/2088) through a combination of different portfolio management techniques. Details are available in the prospectus and the ESG website disclosure of the Sub-fund. The investment objective of the Green Ash Short Duration is to achieve income and capital appreciation by investing in globally issued bonds and other debt securities that demonstrate environmental, social and governance (ESG) criteria. The aim of the Investment manager is to target a duration of the portfolio not exceeding 2.5 years and invest a maximum of 25% of the portfolio in securities which have a legal final maturity exceeding 4 years but less than 5 years. Securities can be denominated in any hard currency, however the Sub-fund's non base, unhedged currency exposure cannot exceed the limit of 10%. The Sub-fund invests directly and indirectly in debt and money market related eligible assets (including floating and fixed rate bonds); at least 55% of its net assets in investment grade securities (i.e. including and higher than Baa3 by Moody's or BBB- by S&P or equivalent rating issued by a recognized rating agency or considered as such by the Investment Manager) and a maximum of 45% in high yield securities. Moreover, the Sub-fund may invest up to 25% of its assets in fixed income securities issued in emerging market countries. Furthermore, the Sub-fund can invest up to 100% in bonds or treasury bills issued by supranational organizations and governments (OECD countries). In order to reach its objective, the Sub-fund can also use structured products and derivative instruments to protect against movements in currencies and security prices for efficient portfolio management. The investor can buy or sell shares on a daily basis (Luxembourg bank business days). This Share Class does not make regular distributions.

Intended Retail Investor: This Product is intended for retail investors with sufficient knowledge and experience in collective investment schemes and similar products, an ability to bear a minor investment loss, and a long-term investment horizon.

What are the risks and what could I get in return?

(A) Summary Risk Indicator



The risk indicator assumes you keep the Product for 5 years. The actual risk can vary significantly if you redeem at an early stage and you may get back less.

The Summary Risk Indicator is a guide to the level of risk of this Product compared to other products. It shows how likely it is that the Product will lose money because of movements in the markets. We have classified this Product as 2 out of 7, which is a low risk class and poor market conditions are very unlikely to impact our capacity to pay you. **Be aware of currency risk** if your reference currency differs from the currency of the Product. You may receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. Investors shall note that the Product may be exposed to further risks such as operational, counterparty, political, sustainability and legal risks that are not included in the Summary Risk Indicator. Recommended holding period: 5 years
