What is the product?

Type: This Product is an investment company qualifying as UCITS Sub-fund in accordance with the UCITS law.

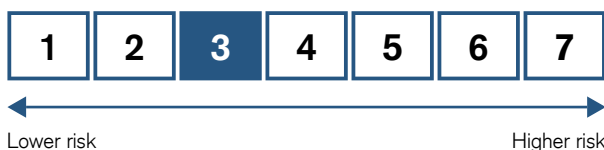
Term: This Product has no maturity date. The Sub-fund has been established for an indefinite period of time. The Board of Directors of the Investment Company is entitled to liquidate, merge or reposition the Product at any time unilaterally in case the Product can no longer be managed in the interest of the investors. The amount the investor will receive upon early termination may be less than the amount invested.

Objectives: The Sub-fund is actively managed without reference to any benchmark. The Green Ash Onyx Fund is an open-end investment fund incorporated in Luxembourg. The Sub-fund promotes environmental, social and governance (ESG) characteristics (within the meaning of Article 8 of Regulation (EU) 2019/2088) through a combination of different portfolio management techniques. Details are available in the prospectus and the ESG website disclosure of the Sub-fund. The Sub-fund's objective is to achieve positive long-term returns over a wide variety of market conditions. The Sub-fund's investment philosophy takes a macroeconomic approach which aims to identify the most attractive investment opportunities across global liquid capital markets. The Sub-fund seeks to achieve these Investment objectives by investing in a wide range of asset classes including equities, fixed income or variable-interest securities, derivatives, exchange traded funds, currencies, commodities and alternative asset classes. The Sub-fund may invest up to 30% of its assets in transferable securities issued by entities domiciled in an emerging country. Furthermore, the Investment Manager may decide to hold up to 100% of the Sub-fund's assets in cash and money market instruments. The Share Class does not make regular distributions.

Intended Retail Investor: This Product is intended for professional and institutional investors, with an ability to bear a minor investment loss, and a long-term investment horizon.

What are the risks and what could I get in return?

(A) Summary Risk Indicator



The risk indicator assumes you keep the Product for 5 years. The actual risk can vary significantly if you redeem at an early stage and you may get back less.

The Summary Risk Indicator is a guide to the level of risk of this Product compared to other products. It shows how likely it is that the Product will lose money because of movements in the markets. We have classified this Product as 3 out of 7, which is a medium-low risk class and poor market conditions are unlikely to impact our capacity to pay you. **Be aware of currency risk** if your reference currency differs from the currency of the Product.
