What is the product?

Type: This Product is an investment company qualifying as UCITS Sub-fund in accordance with the UCITS law.

Term: This Product has no maturity date. The Sub-fund has been established for an indefinite period of time. The Board of Directors of the Investment Company is entitled to liquidate, merge or reposition the Product at any time unilaterally in case the Product can no longer be managed in the interest of the investors. The amount the investor will receive upon early termination may be less than the amount invested.

Objectives: The Sub-fund is actively managed, without reference to a benchmark aiming to achieve long-term capital growth and positive returns. The Sub-fund promotes environmental, social and governance (ESG) characteristics (within the meaning of Article 8 of Regulation (EU) 2019/2088) through a combination of different portfolio management techniques. Details are available in the prospectus and the ESG website disclosure of the Sub-fund. The Sub-fund invests in a diversified portfolio consisting of equities and other equity securities or rights of companies in developed markets (max. 75%), fixed income or variable-interest securities, debt instruments or rights and other interest bearing investments (max. 40%), including contingent convertible bonds (max. 20%), as well as in units in other UCITS and/or other UCIs, including exchange traded funds (max. 100%). The Sub-fund is not limited to a certain currency, sector or geographical scope, although investments in emerging markets will not exceed 20% of its net assets. In normal market conditions, the Sub-fund may invest in bank deposits at sight, such as cash (max. 20%) and in convertible bonds, bonds with warrants or Money Market Instruments (max 49%), however, in exceptionally unfavourable market conditions, both these investments may temporarily increase up to 100%. In order to achieve its objective, the Sub-fund can use derivative instruments, and structured products to protect against movements in currencies and security price, for investment purposes and for efficient portfolio management. The Sub-fund may enter into a total return swap by receiving the return of a reference portfolio (max. 20% of assets). The investor can buy or sell shares of the Sub-fund on a daily basis, as further defined in the prospectus. This Share Class does not make regular distributions. The Sub-fund shall bear the costs of standard brokerage and bank charges incurred by the Sub-fund through securities transactions in relation to the portfolio.

Intended Retail Investor: This Product is intended for retail investors with sufficient knowledge and experience in collective investment schemes and similar products, an ability to bear a minor investment loss, and a long-term investment horizon.

What are the risks and what could I get in return?
