## What is this product?

## Туре

The Product is a unit of the Sub-fund Wellington Global Opportunities Equity Fund (the "Fund") which is part of the Wellington Management Funds (Luxembourg) (the "Umbrella Fund"), an open-ended investment fund organised initially under Part I of the Luxembourg 1988 Law as an unincorporated mutual investment fund (fonds commun de placement) and now authorised under Part I of the 2010 Law. The Umbrella Fund qualifies as UCITS under Article 1. paragraph 2) points a) and b) of the Directive.

### Term

The Umbrella Fund and the Fund do not have a fixed term or maturity period, but the Management Company, with the approval of the Depositary, is entitled to give notice of the Umbrella Fund's dissolution at any time. In the event that the Management Company considers that changes in the political, economic, military, regulatory or business environments, or reductions in the scale of a Fund's total net assets compromise the effective management of a Fund, then the Management Company is empowered to liquidate the Fund at any time.

## Objectives

The Fund seeks long-term total returns.

The Fund will be actively managed in excess of the MSCI All Country World Index (the "Index"), principally investing in equity securities issued by companies worldwide. The Index is market capitalisation weighted and designed to measure the equity market performance of developed and emerging markets. The Fund will generally be diversified and will generally invest in mid to large capitalisation companies.

The Fund will invest, either directly or via derivatives, in shares and other securities with equity characteristics such as preferred stocks, convertible securities or depository receipts.

While there are no restrictions on the Fund's ability to use derivatives for investment purposes (such as gaining exposure to a security), derivatives are mainly used to hedge (manage) risk.

The Index may be considered during portfolio construction and is used for performance comparison purposes. Fund securities may be components of the Index but are not expected to have similar weightings. The Investment Manager may limit the extent that security, country and sector weightings differ from the Index but this should not be expected to limit the Fund's ability to achieve long-term total returns in excess of the Index.

The Fund will support certain environmental characteristics by investing at least 70% of its net assets in companies rated 1-3 for environmental on an internal rating scale of 1-5, where 1 is the highest rating.

## Income policy

Any income allocated to the Unit class from the Fund is reinvested.

### **Dealing Frequency**

Units can be bought or sold daily in accordance with the Prospectus.

#### Intended retail Investor

The Fund is intended for basic retail investors with a long-term investment horizon seeking capital appreciation and who are able to bear capital loss.

The price is based on the net asset value per unit of each class determined at the valuation point.
