What is this product?**Type**

The Product is a unit of the Sub-fund Wellington Asian Opportunities Fund (the "Fund") which is part of the Wellington Management Funds (Luxembourg) (the "Umbrella Fund"), an open-ended investment fund organised initially under Part I of the Luxembourg 1988 Law as an unincorporated mutual investment fund (fonds commun de placement) and now authorised under Part I of the 2010 Law. The Umbrella Fund qualifies as UCITS under Article 1. paragraph 2) points a) and b) of the Directive.

Term

The Umbrella Fund and the Fund do not have a fixed term or maturity period, but the Management Company, with the approval of the Depositary, is entitled to give notice of the Umbrella Fund's dissolution at any time. In the event that the Management Company considers that changes in the political, economic, military, regulatory or business environments, or reductions in the scale of a Fund's total net assets compromise the effective management of a Fund, then the Management Company is empowered to liquidate the Fund at any time.

Objectives

The Fund seeks long-term total returns in excess of the MSCI All Country Asia Ex Japan Index (the "Index").

The Fund will be actively managed, investing primarily in companies listed or operating in the Asia ex Japan region. The Fund is unconstrained, investing in developed and emerging markets in the region with country and sector allocations driven by stock selection.

The Fund will invest primarily in shares and other securities with equity characteristics issued by companies with market capitalisations in excess of US\$500 million. Up to 15% of the Fund may be invested in companies domiciled outside of the Asia ex Japan region. The Fund may invest either directly or via derivatives.

Derivatives may be used to hedge (manage) risk and for investment purposes (such as gaining exposure to a security).

The MSCI All Country Asia ex Japan Index ("the Index") serves as a reference benchmark for performance comparison purposes. Whilst Fund securities may be components of the Index, the Index is not considered during portfolio construction

and the Investment Manager will not manage the extent to which Fund securities differ from the Index.

The Fund will seek to support certain social characteristics by assessing and promoting the adoption of appropriate practices among investee companies with regard to modern slavery risk management, including with regards to forced labour, child labour and debt bondage ("Modern Slavery"), through the application of Wellington Management Group's EM Modern Slavery Policy.

To further promote appropriate policies and practices with regard to child labour and forced labour, the Fund excludes companies which have been assessed to be in violation of United Nations Global Compact principles 4 (businesses should uphold the elimination of all forms of forced and compulsory labour) or 5 (businesses should uphold the effective abolition of child labour) due to known controversies regarding child labour or forced labour.

A minimum of 70% of the Fund's net assets will be aligned to the environmental or social characteristics of the Fund.

The currency of this Unit class is different to the base currency of the Fund and so the performance of the Unit class will be subject to the impact of the movement of the exchange rate between the currencies.

Income policy

Any income allocated to the Unit class from the Fund is reinvested.

Dealing Frequency

Units can be bought or sold daily in accordance with the Prospectus. The base currency of the Fund is USD.

Intended retail Investor

The Fund is intended for basic retail investors with a long-term investment horizon seeking capital appreciation and who are able to bear capital loss. An investment in the Fund should not constitute a substantial proportion of an investment portfolio and may not be appropriate for all investors.

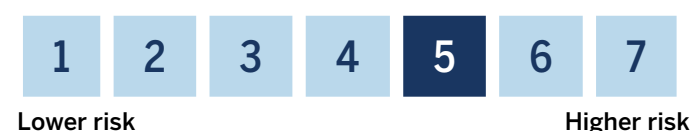

What are the risks and what could I get in return?

Risk Indicator



The risk indicator assumes you keep the product for 5 years.

The actual risk can vary significantly if you cash in at an early stage and you may get back less.

Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

Performance Scenarios

What happens if Wellington Luxembourg S.à r.l. is unable to pay out?

The assets of the Fund are held in safekeeping by its depositary. In the event of the insolvency of the Management Company, the Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund. The Depositary will also be liable to the Fund and the investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfil its obligations (subject to certain limitations).

There is no compensation or guarantee scheme protecting you from a default of the Fund's depositary.

What are the costs?

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. How long should I hold it and can I take money out early?

Recommended holding period: 5 years

This product has no required minimum holding period but is designed for long-term investment; you should have an investment horizon of at least 5 years.

The Management Company shall redeem units of this Fund at the redemption price on each dealing day. Redemptions of the applicable Fund will be effected at the valuation point on the relevant dealing day. The price is based on the net asset value per unit of each class determined at the valuation point. Redemption requests received after the dealing deadline will be treated as having been received by the following dealing deadline unless otherwise determined by the Management Company.
