What is this product?**Type**

The Product is a unit of the Sub-fund Wellington Global Total Return Fund (UCITS) (the "Fund") which is part of the Wellington Management Funds (Luxembourg) (the "Umbrella Fund"), an open-ended investment fund organised initially under Part I of the Luxembourg 1988 Law as an unincorporated mutual investment fund (fonds commun de placement) and now authorised under Part I of the 2010 Law. The Umbrella Fund qualifies as UCITS under Article 1. paragraph 2) points a) and b) of the Directive.

Term

The Umbrella Fund and the Fund do not have a fixed term or maturity period, but the Management Company, with the approval of the Depositary, is entitled to give notice of the Umbrella Fund's dissolution at any time. In the event that the Management Company considers that changes in the political, economic, military, regulatory or business environments, or reductions in the scale of a Fund's total net assets compromise the effective management of a Fund, then the Management Company is empowered to liquidate the Fund at any time.

Objectives

The Fund seeks absolute returns above a cash benchmark over the medium to long term primarily through investing, either directly or indirectly, in a range of fixed income asset classes.

The Fund will be actively managed, investing globally across multiple fixed income investment strategies. The impact of each investment strategy on the aggregate risk of the Fund is individually and collectively evaluated. The Fund will be diversified across investment styles, sectors, themes and time horizons. The ICE BofA Merrill Lynch 3-Month T-Bill Index (the "Index") will serve as the cash benchmark. The Index represents short-term US Government securities with a remaining term to final maturity of less than three months.

The Fund primarily invests, either directly or via derivatives, in bonds (fixed or floating rate) issued by government, agency, supranational or corporate issuers; mortgage and other asset-backed securities and may also hold cash and cash equivalents in multiple currencies without restriction. Currency exposure, not related to the bond and cash equivalent positions, may be assumed.

Derivatives will be used to hedge (manage) risk and/or volatility and for investment purposes (such as gaining exposure to a security, to create leverage and/or a short position). Derivatives will form a significant part of the strategy and will impact performance.

The Fund will seek to support certain environmental and social characteristics and will abide by the following binding restrictions:

- The Fund will restrict its investment in sovereign issuers where fossil fuels makeup more than two-thirds of exports to a maximum of 1.5% of the Fund's Net Asset Value.

- For investments made in corporate bonds, the Fund will not invest in issuers that the Investment Manager believes have the lowest environmental and social standards relative to their industry peers. Where corporate issuers have received an E and a S Rating, the Fund will only invest in those corporate issuers that are rated 1-4 using a rating scale of 1-5, where 1 is the highest rating.

A minimum of 51% of the Fund's net assets will be aligned to the environmental or social characteristics of the Fund.

This Unit class will, via derivatives, seek to provide similar performance to the Fund in its base currency by limiting the impact of the movement of exchange rates between the currency of the Unit class and the base currency of the Fund.

Income policy

Any income allocated to the Unit class from the Fund is reinvested.

Dealing Frequency

Units can be bought or sold daily in accordance with the Prospectus. The base currency of the Fund is USD.

Intended retail investor

The Fund is intended for basic retail investors with a long-term investment horizon seeking capital appreciation and income and who are able to bear capital loss.

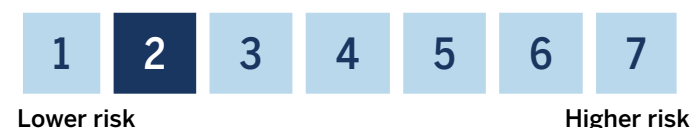

What are the risks and what could I get in return?

The risk indicator assumes you keep the product for 5 years.

Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

Performance Scenarios

What happens if Wellington Luxembourg S.à r.l. is unable to pay out?

The assets of the Fund are held in safekeeping by its depositary. In the event of the insolvency of the Management Company, the Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund. The Depositary will also be liable to the Fund and the investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfil its obligations (subject to certain limitations).

There is no compensation or guarantee scheme protecting you from a default of the Fund's depositary.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods. We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the 5 year holding period we have assumed the product performs as shown in the moderate scenario

How long should I hold it and can I take money out early?

Recommended holding period: 5 years

This product has no required minimum holding period but is designed for long-term investment; you should have an investment horizon of at least 5 years.

The Management Company shall redeem units of this Fund at the redemption price on each dealing day. Redemptions of the applicable Fund will be effected at the valuation point on the relevant dealing day. The price is based on the net asset value per unit of each class determined at the valuation point. Redemption requests received after the dealing deadline will be treated as having been received by the following dealing deadline unless otherwise determined by the Management Company.
