What is this product?

Type

The Product is a unit of the Sub-fund Wellington Climate Strategy Fund (the "Fund") which is part of the Wellington Management Funds (Luxembourg) (the "Umbrella Fund"), an open-ended investment fund organised initially under Part I of the Luxembourg 1988 Law as an unincorporated mutual investment fund (fonds commun de placement) and now authorised under Part I of the 2010 Law. The Umbrella Fund qualifies as UCITS under Article 1. paragraph 2) points a) and b) of the Directive.

Term

The Umbrella Fund and the Fund do not have a fixed term or maturity period, but the Management Company, with the approval of the Depositary, is entitled to give notice of the Umbrella Fund's dissolution at any time. In the event that the Management Company considers that changes in the political, economic, military, regulatory or business environments, or reductions in the scale of a Fund's total net assets compromise the effective management of a Fund, then the Management Company is empowered to liquidate the Fund at any time.

Objectives

The Fund seeks long-term total returns in excess of the MSCI All Country World Index (the "Index ") while contributing to the environmental objective of climate risk mitigation and adaptation.

The Fund has an environmental objective of climate risk mitigation (to address the causes and minimise the impacts of climate change) and adaptation (reduce the negative effects of climate change or help communities adapt to the impact of climate change).

The Fund will invest at least 90% of its net assets in companies whose products, services or capital provide for decarbonisation, energy/resource efficiency and resiliency to climate change. The investment opportunity set of the Fund will be segmented into five major categories: Low Carbon Electricity, Low Carbon Transport, Water and Resources Management, Energy Efficiency and Climate Resilient Infrastructure.

The Fund will be actively managed and achieve its objectives by investing primarily in equity securities of worldwide publicly traded companies.

The investment approach is based on the Investment Manager's assessment of both the climate stewardship and economic capital of the target companies. In other words, the fund quantifies the financial and environmental impacts of companies' projects and thus assesses the sustainability of investment returns.

The Investment Manager carries out bottom-up company specific analysis to compare against current market security prices and broader market sentiment.

The Fund will base its investment selection on in-depth fundamental analysis, but will assess on an ongoing basis that allocations to various sectors and themes are in line with top-down macroeconomic views.

The Fund will invest in shares and other securities with equity characteristics, such as preferred stock, warrants, rights, and depository receipts. The Fund may invest either directly or via derivatives.

While there are no restrictions on the Fund's ability to use derivatives for investment purposes (such as gaining exposure to a security), derivatives are mainly used to hedge (manage) risk.

The Index serves as a reference benchmark for performance comparison purposes. Whilst Fund securities may be components of the Index, the Index is not considered during portfolio construction and the Investment Manager will not manage the extent to which Fund securities differ from the Index.

The Fund seeks to fulfil its environmental objective by investing at least 90% of its net assets in shares of companies whose products or services meet the Investment Manager's climate stewardship criteria around mitigation and adaptation.

The Fund will seek to support certain environmental characteristics by aiming to achieve net zero emissions by 2050 in alignment with the Paris Agreement, by investing a minimum of 25% of its NAV in companies which have established, or have committed to establish science-based targets, with this percentage increasing to a minimum of 50% by 2030 and 100% by 2040.

The Fund will also exclude the top 100 natural gas, thermal coal and oil companies respectively based on reserves.

The currency of this Unit class is different to the base currency of the Fund and so the performance of the Unit class will be subject to the impact of the movement of the exchange rate between the currencies.

Income policy

Any income allocated to the Unit class from the Fund is reinvested.

Dealing Frequency

Units can be bought or sold daily in accordance with the Prospectus. The base currency of the Fund is USD.

Intended retail Investor

The Fund is intended for basic retail investors with a long-term investment horizon seeking capital appreciation and who are able to bear capital loss. An investment in the Fund should not constitute a substantial proportion of an investment portfolio and may not be appropriate for all investors.

What are the risks and what could I get in return?

Risk Indicator



The risk indicator assumes you keep the product for 5 years.

Performance Scenarios

What happens if Wellington Luxembourg S.à r.l. is unable to pay out?

The assets of the Fund are held in safekeeping by its depositary. In the event of the insolvency of the Management Company, the Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund. The Depositary will also be liable to the Fund and the investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfil its obligations (subject to certain limitations).

There is no compensation or guarantee scheme protecting you from a default of the Fund's depositary.

What are the costs?

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

- In the first year you would get back the amount that you invested (0 % annual return). For the 5 year holding period we have assumed the product performs as shown in the moderate scenario

How long should I hold it and can I take money out early?

Recommended holding period: 5 years

This product has no required minimum holding period but is designed for long-term investment; you should have an investment horizon of at least 5 years.

The Management Company shall redeem units of this Fund at the redemption price on each dealing day. Redemptions of the applicable Fund will be effected at the valuation point on the relevant dealing day. The price is based on the net asset value per unit of each class determined at the valuation point. Redemption requests received after the dealing deadline will be treated as having been received by the following dealing deadline unless otherwise determined by the Management Company.
