What is this product?

Type

The Product is a share of the Sub-fund Wellington Responsible Values Multi-Sector Credit Fund (the "Fund") which is part of the Wellington Management Funds (Luxembourg) II SICAV (the "Umbrella Fund"), an open-ended investment fund with variable capital (société d'investissement à capital variable) of the umbrella type and organised under the Luxembourg law of 13 February 2007 (the "2007 Law") on specialised investment funds, as amended from time to time, and qualifies as an alternative investment fund (the "AIF") pursuant to the law of 12 July 2013 on alternative investment fund managers (the "AIFM Law") and the AIFMD.

Term

The Umbrella Fund and the Fund do not have a fixed term or maturity period, but the Management Company, with the approval of the Depositary, is entitled to give notice of the Umbrella Fund's dissolution at any time. In the event that the Management Company considers that changes in the political, economic, military, regulatory or business environments, or reductions in the scale of a Fund's total net assets compromise the effective management of a Fund, then the Management Company is empowered to liquidate the Fund at any time.

Objectives

The Fund seeks long-term total returns (income and capital appreciation).

The Investment Manager will actively manage the Fund, seeking to achieve the objective by allocating its assets across a broadly diversified portfolio of both direct and derivative credit instruments, including emerging market debt, high yield debt, and bank loans, from a defined responsible investment universe which restricts investment in the following industries: fossil fuels, controversial and conventional weapons, tobacco and cannabis. However, the inclusion of an issuer from an unrestricted industry does not mean that its core business is necessarily related to responsible investing.

The Fund primarily invests, either directly or via derivatives, in bonds (fixed or floating rate) issued by corporate, government, agency, or supranational issuers globally; bank loans; mortgage and other asset-backed securities; convertible bonds; fixed income ETFs and cash and cash equivalents. The Fund invests in higher-yielding sectors of the credit market and has no limitations on the credit

quality of individual securities, however the average credit quality of the Fund should generally be expected to be B- or better. The average duration of the Fund will generally range between 2-6 years.

Derivatives will be used to hedge (manage) risk and/or volatility and for investment purposes (such as gaining exposure to a security, to create leverage and/or a short position). Derivatives will form a significant part of the strategy and will impact performance.

The Fund does not consider a benchmark during portfolio construction or for performance purposes.

The Fund will seek to support certain environmental and social characteristics and will abide by the following binding restrictions:

- o The Fund will apply exclusions to companies with business activities related to fossil fuel, controversial weapons, nuclear weapons, tobacco and cannabis

- o The Fund will have between 5-10% exposure to debt issued by companies and organisations that Investment Manager believes are addressing the world's social and environmental challenges in a differentiated way through their products, services and projects

Income policy

Any income allocated to the Unit class from the Fund is reinvested.

Dealing Frequency

Shares can be bought or sold daily in accordance with the Offering Memorandum.

Intended retail Investor

The Fund is intended for informed retail investors with a long-term investment horizon seeking capital appreciation and who are able to bear capital loss. An investment in the Fund should not constitute a substantial proportion of an investment portfolio and may not be appropriate for all investors.

What are the risks and what could I get in return?

Risk Indicator



The risk indicator assumes you keep the product for 5 years.

Performance Scenarios

What happens if Wellington Luxembourg S.à r.l. is unable to pay out?

The assets of the Fund are held in safekeeping by its depositary. In the event of the insolvency of the Management Company, the Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund. The Depositary will also be liable to the Fund and the investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfil its obligations (subject to certain limitations).

There is no compensation or guarantee scheme protecting you from a default of the Fund's depositary.

What are the costs?

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. How long should I hold it and can I take money out early?

Recommended holding period: 5 years

This product has no required minimum holding period but is designed for long-term investment; you should have an investment horizon of at least 5 years.

The Management Company shall redeem shares of any Fund at the redemption price on each dealing day. Redemptions of the applicable Fund will be effected at the valuation point on the relevant dealing day. The price is based on the net asset value per share of each class determined at the valuation point. Redemption requests received after the dealing deadline will be treated as having been received by the following dealing deadline unless otherwise determined by the Management Company.
