WHAT IS THIS PRODUCT?

Type:

Collective investment scheme in accordance with the Swiss Federal Act on Collective Investment Schemes (CISA). The fund's performance depends on the performance of the underlying investments, as further described in the «Objectives» section.

Term:

The term of this product is indefinite and it has no maturity date. The manufacturer may reposition the product at any time, merge it with another product or terminate it unilaterally and without notice.

Objectives:

The investment objective of the fund is mainly to achieve a long-term increase in the value of the portfolio in CHF in compliance with a sustainably oriented investment policy of the asset manager, while accepting significant fluctuations in value.

As an umbrella fund, the fund invests worldwide in equities and bonds, at least 50% and no more than 100% of its assets being invested in equity securities. In addition, the fund may to a lesser extent make indirect investments in real estate, precious metals, commodities and hedge funds. A minimum of two-thirds of investments satisfy ESG (Environmental, Social, Governance) criteria to ensure a sustainable investment approach.

Fund units are issued and redeemed basically on every bank business day in Switzerland.

Earnings and profits of the unit class are distributed.

Thurgauer Kantonalbank, Bankplatz 1, CH - 8570 Weinfelden, was appointed as the custodian bank.

The liability of the assets of a fund within the umbrella fund for claims against the assets of another fund is excluded.

Risk indicator

WHAT HAPPENS IF SWISSCANTO FUND MANAGEMENT COMPANY LTD., ZURICH, IS UNABLE TO PAY OUT?

The assets of the Fund and the assets of the fund management company are held separately. Therefore, a default by the fund management company will not affect the value of your investment. If the custodian bank goes bankrupt, the Fund's assets deposited with the custodian bank will not be included in the bankruptcy estate but will be segregated for the benefit of the Fund. In such a case, the claims by the Fund against the custodian bank in the form of privileged deposits are given priority by the custodian bank, but are otherwise treated as ordinary claims in the bankruptcy proceedings.
