Product:	Swisscanto (CH) IPF I Index Equity Fund Small Cap World (ex CH) Responsible NTH1 CHF (hereinafter «Product») is a unit class of the sub-fund Swisscanto (CH) IPF I Index Equity Fund Small Cap World (ex CH) Responsible (hereinafter «Fund»), a sub-fund of the umbrella fund Swisscanto (CH) Institutional Pension Fund I (IPF I).

WHAT IS THIS PRODUCT?

Type:

Collective investment scheme in accordance with the Swiss Federal Act on Collective Investment Schemes (CISA). The fund's performance depends on the performance of the underlying investments, as further described in the «Objectives» section.

Term:

The term of this product is indefinite and it has no maturity date. The manufacturer may reposition the product at any time, merge it with another product or terminate it unilaterally and without notice.

Objectives:

The fund primarily invests in shares and other equity securities that are part of the benchmark index. ESG criteria (environment, social, governance) are systematically taken into account in the investment selection process in accordance with responsibility requirements.

The investment objective of the fund is to replicate the return and risk characteristics of the benchmark index.

Reference index: MSCI World ex Switzerland Small Cap Index TR Net Hedged in CHF

Fund units are issued and redeemed basically on every bank business day in Switzerland.

Earnings and profits of the unit class are not distributed, but reinvested.

Cantonal Bank of Zurich, Bahnhofstrasse 9, 8001 Zurich, was appointed as the custodian bank.

The liability of the assets of a fund within the umbrella fund for claims against the assets of another fund is excluded.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

Risk indicator

The risk indicator assumes you keep the product for 10 years.

We have classified this product as class 4 out of 7, which is a medium risk class.

Reasons for this risk classification: Equity market and company-specific price volatility.

WHAT HAPPENS IF SWISSCANTO FUND MANAGEMENT COMPANY LTD., ZURICH, IS UNABLE TO PAY OUT?

The assets of the Fund and the assets of the fund management company are held separately. Therefore, a default by the fund management company will not affect the value of your investment. If the custodian bank goes bankrupt, the Fund's assets deposited with the custodian bank will not be included in the bankruptcy estate but will be segregated for the benefit of the Fund. In such a case, the claims by the Fund against the custodian bank in the form of privileged deposits are given priority by the custodian bank, but are otherwise treated as ordinary claims in the bankruptcy proceedings.

WHAT ARE THE COSTS?

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. - CHF 10 000 is invested.
- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.
