<b>Product:</b>	GKB (LU) Staatsanleihen Welt ESG NH EUR (hereinafter «Product») is a unit class of the sub-fund GKB (LU) Staatsanleihen Welt ESG (hereinafter «Fund»), a sub-fund of the umbrella fund GKB (LU).

### WHAT IS THIS PRODUCT?

#### Type:

Investment fund (UCITS) under Luxembourg law, which is subject to the law for undertakings for collective investment of December 17, 2010 and which is a fonds commun de placement under this law. The fund's performance depends on the performance of the underlying investments.

#### Term:

The term of this product is indefinite and it has no maturity date. The manufacturer may reposition the product at any time, merge it with another product or terminate it unilaterally and without notice.

#### Objectives:

The investment objective is primarily to generate an appropriate investment return, taking into account the investment criterion of 'capital protection'. The fund invests at least 51% of its assets in bonds and other debt securities that are predominantly issued by public-sector borrowers worldwide. ESG criteria are systematically taken into account in the selection of at least 2/3 of the investments in accordance with responsible guidelines. The fund is classified under Art. 8 of Regulation (EU) 2019/2088 of the European Parliament and of the Council of 27 November 2019 on sustainability-related disclosures in the financial services sector («SFDR»).

The securities are selected on a discretionary basis using a consistent investment process (active management). With regard to portfolio composition, the selection of stocks and the associated weightings are focused on companies from the J.P. Morgan Government Bond Index (GBI) Hedged in EUR. The portfolio composition may deviate moderately from this benchmark index. The investment policy is to outperform the benchmark index. The Asset Manager may at any time deviate – significantly or insignificantly, positively or negatively – from the benchmark index by actively overweighting or underweighting individual securities and sectors based on market conditions and risk assessments.

Fund units are issued and redeemed basically on every bank business day in Luxembourg.

Earnings and profits of the unit class are not distributed, but reinvested.

CACEIS Bank, Luxembourg Branch, 5, Allée Scheffer, L-2520 Luxembourg, was appointed as the custodian bank (depository).

The liability of the assets of a fund within the umbrella fund for claims against the assets of another fund is excluded.

The investor has the right to convert his investment in the units of one sub-fund into the units of another sub-fund. Further information on unit conversion procedures can be found in the sales prospectus and the management regulations.

### WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

The risk indicator assumes you keep the product for 5 years.

We have classified this product as class 2 out of 7, which is a low-risk class.

Reasons for this risk classification: Interest-rate premium; Yield curve; Foreign currency risks.

**Be aware of currency risk.** You may receive payments in a different currency, so the final return you will get may depend on the exchange rate between the two currencies. This type of risk is not considered in the indicator shown above.

## WHAT HAPPENS IF SWISSCANTO ASSET MANAGEMENT INTERNATIONAL S.A., LUXEMBOURG, IS UNABLE TO PAY OUT?

The assets of the Fund and the assets of the management company are held separately at the custodian bank. Therefore, a default by the management company will not affect the value of your investments in the Fund. If the custodian bank goes bankrupt, the Fund's assets deposited with the custodian bank will not be included in the bankruptcy estate but will be segregated for the benefit of the Fund.

## WHAT ARE THE COSTS?

### Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs.
