What is this product?

Type

This product is a UCITS sub-fund of a variable capital umbrella investment company with segregated liability between sub-funds authorised by the Central Bank of Ireland pursuant to the European Communities (Undertakings for Collective Investment in Transferable Securities) Regulations 2011, as amended.

Subject to the conditions set down in the prospectus, shareholders may exchange all or part of their shares of this fund for shares of another fund of the company. Please refer to the section entitled "How To Exchange Shares" in the prospectus for further details.

Term

This product has no fixed term.

Objectives

The fund aims to seek maximum current income consistent with the preservation of capital and daily liquidity, through investing in a diversified portfolio of high-quality short-duration securities and instruments, using prudent investment management principles

Investment Policy

The fund aims to achieve this objective by investing primarily in a range of "investment grade" fixed income securities and instruments (which are similar to loans that pay a fixed or variable rate of interest) issued by companies or governments from around the world and mainly priced in euros. The fund intends to measure its performance against the ICE BofA 3-Month German

Treasury Bill Index (the "Benchmark "). The fund is considered to be actively

managed in reference to the Benchmark by virtue of the fact that it uses the Benchmark for performance comparison purposes. However the Benchmark is not used to define the portfolio composition of the fund or as a performance target. The fund may also invest up to 10% in "non-investment grade" securities. Non-

investment grade securities are considered to be more risky, but typically produce a higher level of income.

The fund may invest in emerging markets, which in investment terms are those conomies that are not as developed. The fund will promote environmental and social characteristics through an exclusion

strategy and, where applicable, issuer engagement.

The fund may invest in derivative instruments (such as futures, options and swaps) rather than directly in the underlying securities themselves. The derivatives return is linked to movements in the underlying assets. The assets held by the fund may be denominated in a wide variety of currencies with non-euro denominated currency exposure limited to 20% of total assets.

The investment advisor may use foreign exchange and related derivative instruments to hedge or implement currency positions

Dealing Day Shares in the fund can normally be redeemed on a daily basis. Please refer to the section entitled "How to Redeem Shares" in the prospectus.

Distribution Policy This share class does not pay out a distribution. Any investment income generated will be reinvested.

Intended retail investor

Typical investors in the Fund will be investors who are looking for a competitive and consistent level of income focusing on capital preservation and high level of liquidity and are looking for a diversified exposure to European fixed income markets, focusing on securities with a shorter duration and are willing to accept the risks and volatility associated with investing in such markets and who have a shorter investment horizon.

This classification is subject to change over time. We have classified this product as 2 out of 7, which is a low risk class. This rates the potential losses from future performance at a low level and poor market conditions are very unlikely to impact the value of your investment.

Be aware of currency risk. In some circumstances, you may receive payments in a different currency, so the final return you will get may depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.
