## What is this product?

Type This product is a UCITS sub-fund of a variable capital umbrella investment company with segregated liability between sub-funds authorised by the Central Bank of Ireland pursuant to the European Communities (Undertakings for Collective Investment in Transferable Securities) Regulations 2011, as amended.


Term This product has no fixed term.

Objectives The fund aims to maximise the total return on your investment through primarily investing in a diversified portfolio of Sterling denominated, investment grade, corporate and credit securities and instruments, using prudent investment

Investment Policy The fund aims to achieve this objective by investing primarily in a range of "investment grade" fixed income securities and instruments (which are similar to unvestment grade Tixed income securities and instruments (which are similar to loans that pay a fixed or variable rate of interest) issued by companies from around the world and mostly priced in Sterling. The average portfolio duration of this fund will vary within two years (plus or minus) of the duration of the ICE BofAML Sterling Non-Gilts Index (the "Index"). Duration measures the sensitivity of the assets to interest rate risk. The longer the duration the higher the sensitivity to changes in interest rates.

## What are the risks and what could I get in return?

#### **Risk Indicator**



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

The fund is considered to be actively managed in reference to the Index by virtue of the fact that the Index is used for duration measurement, calculating the global exposure of the fund using the relative VaR methodology and for performance comparison purposes. Certain of the fund's securities may be components of and may have similar weightings to the Index. However, the Index is not used to define the portfolio composition of the fund or as a performance target and the fund may be wholly invested in securities which are not constituents of the Index. wholly invested in securities which are not constituents of the Index. The fund may also invest up to 15% in "non-investment grade" securities. Non-

The fund may invest in emerging markets, which in investment terms are those economies that are not as developed.

The assets held by the fund may be denominated in a wide variety of currencies with non-GBP currency exposure limited to 20% of total assets. Distribution Policy This share class does not pay out a distribution. Any investment income generated will be reinvested.

#### Intended retail investor

ypical investors in the Fund will be investors who are looking to maximise total return through a combination of both income and capital growth and are looking for a diversified exposure to primarily UK fixed income markets and are willing to accept the risks and volatility associated with investing in such markets and who have an investment horizon over the medium to long term.

#### This classification is subject to change over time.

We have classified this product as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level and poor market conditions are unlikely to impact the value of your investment.
