## What is this product?


Objectives The fund aims to maximise the total return on your investment through seeking to provide exposure to attractively priced Capital Securities, using prudent investment

Investment Policy The fund aims to achieve this objective by investing at least 80% of its assets in a global portfolio of Capital Securities. Capital Securities are fixed income securities (loans that pay a fixed or variable rate of interest), contingent convertible bonds and/or equities issued by financial institutions such as banks and insurance companies The securi

The securities will be both "investment grade" and "non-investment grade. Non-investment grade securities are considered to be more risky, but typically produce a

## What are the risks and what could I get in return?

#### **Risk Indicator**

Distribution Policy This share class does not pay out a distribution. Any investment income generated will be reinvested.

### Intended retail investor

Typical investors in the Fund will be investors looking for focused exposure to Capital Securities who are willing to accept the risks and volatility associated with investing in global fixed income markets and who have an investment horizon over the medium to long term.

This classification is subject to change over time.

We have classified this product as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level and poor market conditions are unlikely to impact the value of your investment.

Be aware of currency risk. In some circumstances, you may receive payments in a different currency, so the final return you will get may depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.
