
The fund aims to maximise the total return on your investment through investing in a diversified portfolio of primarily investment grade bonds of varying maturities, using prudent investment management principles. **Investment Policy**

The fund aims to achieve this objective by investing primarily in a range of "investment grade" fixed income securities and instruments (which are similar to loans that pay a fixed or variable rate of interest) issued by companies or governments from around the world and mainly priced in euros. The average portfolio duration of the fund will normally vary from zero to five years

The average portfolio duration of the fund will normally vary from zero to five years based on the investment advisor's forecast for interest rates. Duration measures the sensitivity of the assets to interest rate risk. The longer the duration the higher the

The fund invests primarily in "investment grade" securities (but may also invest up to 20% in "non-investment grade" securities). Non-investment grade securities are considered to be more risky, but typically produce a higher level of income.

The fund intends to measure its performance against the Euro Short-Term Rate (ε STR) (the "Benchmark"). The fund is considered to be actively managed in reference to the Benchmark by virtue of the fact that it uses the Benchmark for performance comparison purposes. However the Benchmark is not used to define the portfolio composition of the fund or as a performance target.

Intended retail investor

Typical investors in the Fund will be investors who are looking to maximise total return and focus on capital preservation and are looking for a diversified exposure to primarily European fixed income markets, focusing on securities with a shorter duration, and who are willing to accept the risks and volatility associated with investing in such markets and who have a shorter investment horizon.

This classification is subject to change over time.We have classified this product as 2 out of 7, which is a low risk class. This rates the potential losses from future performance at a low level and poor market conditions are very unlikely to impact the value of your investment.

Be aware of currency risk. In some circumstances, you may receive payments in a different currency, so the final return you will get may depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.
