## What is this product?

UBS (CH) Bond Fund is a contractually-based investment fund under Swiss law with multiple sub-funds (umbrella fund) of the "Securities funds" category of the Swiss Federal Act on Collective Investment Schemes of 23 June 2006.

## Term

This product does not have a maturity date (in other words, it is open-ended). The manufacturer may terminate the product early. The amount you would receive if such early termination took place might be lower than the amount you invested.

The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

#### Objectives

The actively managed sub-fund primarily invests in bonds, notes, money market instruments and other fixed or floating-rate debt securities and rights of private and public sector issuers worldwide, denominated in Swiss francs or other currencies.

The sub-fund manager, acting at his/her own discretion but within the prescribed investment restrictions, combines various carefully selected issuers and securities with different maturities with the aim of achieving a medium-term performance that is above the typical return on cash holdings in Swiss francs (CHF). The sub-fund seeks to keep the average duration between zero and two years.

The fund's return depends primarily on interest rates, issuer creditworthiness and interest income. The return may also be affected by currency fluctuations where active or unhedged positions exist.

The income from this share class is reinvested (reinvestment).

#### Intended retail investor

This fund applies to retail investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at preserving the investment value, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy short term investment needs. The fund is only suited to be acquired within a discretionary mandate.

## What happens if UBS Fund Management (Switzerland) AG is unable to pay out?

In addition, in relation to UBS Switzerland AG, which as the Fund's custodian is responsible for the safekeeping of its assets (the "Custodian"), there is a potential risk of default in the event that the Fund's assets held with the Custodian are lost. # What are the costs?
