What is this product?

Type

UBS (Lux) Bond Fund is an undertaking for collective investment in transferable securities (UCITS) with the legal status of a Fonds Commun de Placement (FCP) established under Part I of the Luxembourg Law of 2010 relating to undertakings for collective investment.

The Product does not have a maturity date (the Product has been established for an indefinite period of time). The Manufacturer may terminate the Product early. The amount you will receive upon early termination may be less than the amount you invested. The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

The actively managed sub-fund invests primarily in government and corporate bonds denominated in Australian dollars that are issued by borrowers with high credit ratings (classified as "investment grade" by the major rating agencies).

The sub-fund uses the benchmark Bloomberg AusBond Composite Index as a reference for portfolio construction, performance assessment, sustainability profile comparison and risk management purposes. It is expected that a significant portion of the relevant sub-fund's investments will form part of the relevant benchmark. The portfolio manager may use its discretion to invest in companies or sectors not included in the relevant benchmark in order to take advantage of specific investment opportunities

This sub-fund promotes environmental and/or social characteristics but does not pursue a sustainable investment objective.

The return of the fund depends primarily on the development of interest rates and creditworthiness of the issuers and the interest income. The return may also be affected by currency fluctuations, where active or unhedged positions exist.

This share class is a distributing share class. Distributions can comprise income and capital, and may be paid out exclusive of fees.

Intended retail investor

This fund applies to retail investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at generating a substantial part of its yield through recurring income, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy short term investment needs. The fund is suited to be acquired by the target client segments without any restriction of the distribution channel or platform.

Costs over time
