What is this product?

Type

UBS (Lux) Bond SICAV is an undertaking for collective investment in transferable securities (UCITS) with the legal status of an open-ended investment company (SICAV) established under Part I of the Luxembourg Law of 2010 relating to undertakings for collective investment.

Term

The Product does not have a maturity date (the Product has been established for an indefinite period of time). The Manufacturer may terminate the Product early. The amount you will receive upon early termination may be less than the amount you invested. The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

Objectives

The actively managed sub-fund invests at least two-thirds of its assets in "green", "social", and "sustainable" bonds, the proceeds of which are used for eligible environmental and social projects, in "sustainability-linked" bonds that contain environmental, social and governance performance indicators that issuers undertake to comply with, and in bonds issued by issuers that generate more than 50% of their revenues from activities that contribute to solutions to environmental and social challenges.

This sub-fund promotes environmental and/or social features but does not pursue a sustainable investment objective.
The sub-fund uses the benchmark ICE Green, Social and Sustainable Bond Custom Index EUR hedged (Bloomberg Ticker: Q5BL) as a reference

The sub-fund uses the benchmark ICE Green, Social and Sustainable Bond Custom Index EUR hedged (Bloomberg Ticker: Q5BL) as a reference for portfolio construction, performance assessment, sustainability profile comparison and risk management purposes. The portfolio manager may use its discretion to invest in companies or sectors not included in the relevant benchmark in order to take advantage of specific investment opportunities.

The return of the fund depends primarily on the development of interest rates and creditworthiness of the issuers and the interest income. The return may also be affected by currency fluctuations, where active or unhedged positions exist.

The income from this share class is reinvested (reinvestment).

Intended retail investor

This fund applies to retail investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at generating a substantial part of its yield through recurring income, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy medium term investment needs. The fund can be acquired by professional investors and through selected distribution channels only.
