What is this product?

Type

UBS (Lux) Equity Fund is an undertaking for collective investment in transferable securities (UCITS) with the legal status of a Fonds Commun de Placement (FCP) established under Part I of the Luxembourg Law of 2010 relating to undertakings for collective investment.

Term

The Product does not have a maturity date (the Product has been established for an indefinite period of time). The Manufacturer may terminate the Product early. The amount you will receive upon early termination may be less than the amount you invested.

The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

Objectives

The actively managed investment fund invests primarily in equities of eurozone companies. The portfolio focuses primarily on large companies, strategically supplemented by small and medium-sized companies. This sub-fund promotes environmental and/or social features but does not pursue a sustainable investment objective.

Based on sound analysis by our local investment specialists, the fund manager combines carefully selected equities of various companies from different countries and sectors with the aim of taking advantage of interesting return opportunities while keeping risks under control.

UBS Asset Management classifies this investment fund as a Sustainability Focus Fund, which promotes environmental and/or social characteristics.

The portfolio manager has discretion to construct the portfolio and is not bound by the benchmark in terms of equities and weighting.

The investment fund is actively managed in relation to the benchmark MSCI EMU (net div. reinv.). The investment fund uses the benchmark MSCI EMU (net div. reinv.) for portfolio composition, performance comparison, to control the ESG profile and risk management.

The return of the fund depends primarily on equity market development and dividend payments.

The income from this share class is reinvested (reinvestment).

Intended retail investor

This fund applies to retail investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at growing the investment value and addresses a preference for Sustainable Investing, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy medium term investment needs. The fund can be acquired by professional investors and through selected distribution channels only.

What happens if UBS Fund Management (Luxembourg) S.A. is unable to pay out?
