What is this product?

Type

The company was established under Part I of the Luxembourg Law of 30 March 1988 relating to Undertakings for Collective Investment as an open-ended investment fund in the legal form of a SICAV on 7 October 1996 and adapted to the requirements of the Law of 2002 in March 2005 and has been subject to the Law of 2010 since 1 July 2011. With effect from 15 June 2011, the company appointed UBS Fund Management (Luxembourg) S.A. as its management company.

Term

The Product does not have a maturity date (the Product has been established for an indefinite period of time). The Manufacturer may terminate the Product early. The amount you will receive upon early termination may be less than the amount you invested.

Objectives

The actively managed investment fund invests primarily in equities of companies from Russia.

Based on sound analysis by our local investment specialists, the fund manager combines carefully selected equities of various companies from different sectors with the aim of taking advantage of interesting return opportunities while keeping risks under control.

The portfolio manager has discretion to construct the portfolio and is not bound by the benchmark in terms of equities and weighting. The investment fund is actively managed without reference to a benchmark.

The fund's return depends primarily on the performance of the equity markets, exchange rate fluctuations and dividend distributions. Income of this share class is reinvested.

Intended retail investor

This fund applies to retail investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at growing the investment value, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy long term investment needs. The fund is suited to be acquired by the target client segments without any restriction of the distribution channel or platform.

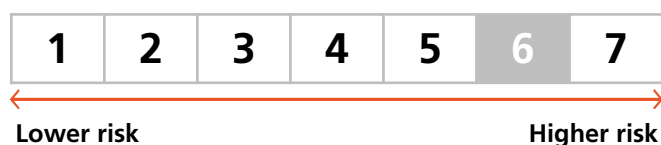

What are the risks and what could I get in return?

Indicator



The risk indicator assumes you keep the product for 8 years.

What happens if UBS Fund Management (Luxembourg) S.A. is unable to pay out?

Losses are not covered by any investor compensation or guarantee scheme. In addition, UBS Europe SE, Luxembourg Branch, the depositary of the Fund responsible for safekeeping its assets (the "Depositary"), is subject to a potential default risk in the event that the assets of the Fund held with the Depositary are lost.
