What is this product?

Type

UBS (Lux) Equity SICAV is an undertaking for collective investment in transferable securities (UCITS) with the legal status of an open-ended investment company (SICAV) established under Part I of the Luxembourg Law of 2010 relating to undertakings for collective investment.

Term

The Product does not have a maturity date (the Product has been established for an indefinite period of time). The Manufacturer may terminate the Product early. The amount you will receive upon early termination may be less than the amount you invested. The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

Objectives

This actively managed investment fund invests its assets predominantly in equities and other equity shares of medium-sized and large capitalisation companies in developed markets and emerging markets. The objective of the investment strategy is to achieve an above-average dividend income compared to the return of the global equity market. The investments of this actively managed fund are widely diversified across sectors and countries. This sub-fund promotes environmental and/or social features but does not pursue a sustainable investment objective.

The fund manager invests the fund's assets as a result of an investment process based on quantitative financial models, seeking to control risk. Stock selection is based on the signals calculated by the quantitative model. This model is continuously being further developed. UBS Asset Management classifies this investment fund as a Sustainability Focus Fund, which promotes environmental and/or social characteristics.

The portfolio manager has the discretion to construct the portfolio and is not bound by the benchmark in terms of weighting. The investment fund is actively managed in relation to the benchmark MSCI AC World (net dividend reinvested). The investment fund uses the benchmark MSCI AC World (net dividend reinvested) for portfolio composition, performance comparison, to manage the ESG profile and for risk management.

The investment fund may invest in Chinese A-shares through the Hong Kong – Shanghai or Shenzhen Stock Connect ("Stock Connect") program.

The return of the fund depends primarily on equity market development and dividend payments.

This share class is a distributing share class. Distributions can comprise income and capital, and may be paid out exclusive of fees. The exchange rate risk of the share class currency is to a large extent hedged against the currency of the fund.

Intended retail investor

This fund applies to retail investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at growing the investment value with a bias to income-generating assets and addresses a preference for Sustainable Investing, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy medium term investment needs. The fund is suited to be acquired by the target client segments without any restriction of the distribution channel or platform.

What are the costs?

Costs over time
