## What is this product?

#### Type

UBS (Lux) Equity SICAV is an undertaking for collective investment in transferable securities (UCITS) with the legal status of an open-ended investment company (SICAV) established under Part I of the Luxembourg Law of 2010 relating to undertakings for collective investment.

#### Term

The Product does not have a maturity date (the Product has been established for an indefinite period of time). The Manufacturer may terminate the Product early. The amount you will receive upon early termination may be less than the amount you invested. The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

## Objectives

The actively managed mutual fund invests primarily in equities of small and medium-sized companies from Asia (excluding Japan), which are characterised by a high degree of flexibility and innovation.

Based on sound analysis by our local investment specialists, the fund manager combines carefully selected equities of various companies from different sectors with the objective of taking advantage of interesting return opportunities while controlling risk.

The portfolio manager has discretion to construct the portfolio and is not bound by the benchmark in terms of equities and weighting. The investment fund is actively managed in relation to the benchmark MSCI All Country Asia (ex Japan) Small & Mid Caps (net div. reinvested). The benchmark is used for portfolio composition, performance comparison and risk management purposes.

The investment fund may invest in Chinese A-shares through the Shenzhen/Shanghai-Hong Kong Stock Connect ("Stock Connect")

This sub-fund promotes environmental and/or social characteristics but does not pursue a sustainable investment objective.

The return of the fund depends primarily on equity market development and their exchange rate fluctuations, as well as dividend payments. The income from this share class is reinvested (reinvestment). The exchange rate risk of the share class currency is not hedged against the currency of the fund.
