# What is this product?

UBS (Lux) Equity SICAV is an undertaking for collective investment in transferable securities (UCITS) with the legal status of an open-ended investment company (SICAV) established under Part I of the Luxembourg Law of 2010 relating to undertakings for collective investment.

The Product does not have a maturity date (the Product has been established for an indefinite period of time). The Manufacturer may terminate the Product early. The amount you will receive upon early termination may be less than the amount you invested. The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

## Objectives

This actively managed investment fund invests its assets predominantly in equities and other equity shares of small, medium-sized and large capitalisation companies in developed markets and emerging markets. This sub-fund promotes environmental and/or social characteristics but does not pursue a sustainable investment objective.

The objective of the investment strategy is to achieve an above-average return on equities compared to the return of the global equity market. Equity return may come from dividends, call option premiums and other sources. The investments of this actively managed fund are widely diversified across sectors and countries. The fund manager invests the fund's assets as a result of an investment process based on quantitative financial models, seeking to control risk. Stock selection is based on the signals calculated by the quantitative model. This model is continuously being further developed.

UBS Asset Management classifies this investment fund as a Sustainability Focus Fund, which promotes environmental and/or social characteristics.

The portfolio manager has the discretion to construct the portfolio and is not bound by the benchmark in terms of weighting. The investment fund is actively managed in relation to the benchmark MSCI AC World (net dividend reinvested). The benchmark is used for portfolio composition, performance comparison and risk management. The return of the fund depends primarily on equity market development and dividend payments.

This share class is a distributing share class. Distributions can comprise income and capital, and may be paid out exclusive of fees.

This fund applies to retail investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at growing the investment value with a bias to income-generating assets and addresses a preference for Sustainable Investing, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy medium term investment needs. The fund can be acquired by professional investors and through selected distribution channels only.

#### Costs over time
