# What is this product?

UBS (Lux) Equity SICAV is an undertaking for collective investment in transferable securities (UCITS) with the legal status of an open-ended investment company (SICAV) established under Part I of the Luxembourg Law of 2010 relating to undertakings for collective investment.

The Product does not have a maturity date (the Product has been established for an indefinite period of time). The Manufacturer may terminate the Product early. The amount you will receive upon early termination may be less than the amount you invested. The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?"

#### Objectives

The actively managed investment fund invests worldwide primarily in equities and other equity shares of small, mid and large-cap companies from developed markets and emerging markets. In this context, the fund focuses on long-term themes that the fund manager considers attractive from an investment perspective, such as global population growth, the demographic trend towards an ageing population or

Based on thorough company screening, taking into account sustainability/ESG criteria, the fund manager combines carefully selected equities of various companies from different countries and sectors with the objective of taking advantage of interesting opportunities while controlling risk. The investment fund will exclude companies or industries whose products or business activities have a negative social or ecological impact. UBS Asset Management categorises this investment fund as a Sustainability Focus fund, which promotes environmental, social and corporate governance characteristics.

The portfolio manager has the discretion to construct the portfolio and is not bound by the benchmark in terms of equities and weighting. The investment fund uses the benchmark MSCI AC World (net dividend reinvested) for portfolio composition, performance comparison, ESG profile management and risk management.

The investment fund may invest in Chinese A-shares through the Hong Kong – Shanghai or Shenzhen Stock Connect ("Stock Connect") programme.
This sub-fund promotes environmental and/or social features, but does not pursue a sustainable investment objective.

The return of the fund depends primarily on equity market development and their exchange rate fluctuations, as well as dividend payments. The income from this share class is reinvested (reinvestment). The exchange rate risk of the share class currency is to a large extent hedged against the currency of the fund.

This fund applies to retail investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at growing the investment value and addresses a preference for Sustainable Investing, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy medium term investment needs. The fund is suited to be acquired by the target client segments without any restriction of the distribution channel or platform.

# What happens if UBS Asset Management (Europe) S.A. is unable to pay out?
