## What is this product?

### Type

UBS (Lux) Equity SICAV is an undertaking for collective investment in transferable securities (UCITS) with the legal status of an open-ended investment company (SICAV) established under Part I of the Luxembourg Law of 2010 relating to undertakings for collective investment.

### Term

The Product does not have a maturity date (the Product has been established for an indefinite period of time). The Manufacturer may terminate the Product early. The amount you will receive upon early termination may be less than the amount you invested.

The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

### Objectives

This investment fund invests its assets globally and primarily in equities and other equity shares of companies that are leaders within their sector in their contribution to a more climate-friendly economy or that benefit from the decarbonisation of the global economy, such as companies active in the clean or renewable energy sector. The objective of the investment fund is, for example, to have a lower temperature adaptation score, a lower CO2 intensity or a higher "green to brown" ratio compared to the benchmark index. This sub-fund promotes environmental and/or social characteristics but does not pursue a sustainable investment objective.

Based on sound analysis from our investment specialists worldwide, the fund manager combines carefully selected equities of various companies from different countries and industries with the aim of taking advantage of interesting return opportunities while keeping risks under control. UBS Asset Management categorises this investment fund as a "Sustainability Focus" fund.

The investment fund uses the benchmark MSCI AC World (net div. reinvested) for portfolio composition, performance comparison, to manage the ESG profile and for risk management.

The investment fund may invest in Chinese A-shares through the Hong Kong – Shanghai or Shenzhen Stock Connect ('Stock Connect') program.

The return of the fund depends primarily on equity market development and their exchange rate fluctuations, as well as dividend payments. The income from this share class is reinvested (reinvestment). The exchange rate risk of the share class currency is to a large extent hedged against the currency of the fund.

### Intended retail investor

This fund applies to retail investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at growing the investment value and addresses a preference for Sustainable Investing, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy medium term investment needs. The fund is suited to be acquired by the target client segments without any restriction of the distribution channel or platform.

### What happens if UBS Fund Management (Luxembourg) S.A. is unable to pay out?

## What are the costs?

### Costs over time
