# What is this product?

#### Type

UBS (Lux) Equity SICAV is an undertaking for collective investment in transferable securities (UCITS) with the legal status of an open-ended investment company (SICAV) established under Part I of the Luxembourg Law of 2010 relating to undertakings for collective investment.

#### Term

The Product does not have a maturity date (the Product has been established for an indefinite period of time). The Manufacturer may terminate the Product early. The amount you will receive upon early termination may be less than the amount you invested. The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

#### Objectives

The actively managed investment fund invests worldwide primarily in equities and other equity shares of companies.

The investment fund aims to take advantage of return opportunities while reducing risk (volatility) and maximum drawdown. Risk reduction may be achieved through the extensive use of derivatives (e.g. options).

The investment fund is actively managed in relation to the benchmark 65% MSCI World 100% Hedged to USD (net div. reinvested) + 35% US Federal Funds Effective Rate. The benchmark is used for portfolio composition, performance comparison and risk management.

This sub-fund promotes environmental and/or social features but does not pursue a sustainable investment objective.

The return of the fund depends primarily on equity market development and their exchange rate fluctuations, as well as dividend payments. The income from this share class is reinvested (reinvestment).

# Intended retail investor

This fund applies to retail investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at growing the investment value with a bias to income-generating assets and addresses a preference for Sustainable Investing, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy medium term investment needs. The fund is suited to be acquired by the target client segments without any restriction of the distribution channel or platform.

# What happens if UBS Asset Management (Europe) S.A. is unable to pay out?

#### What are the costs?

#### Costs over time
