What is this product?

Type

UBS (Lux) Equity SICAV is an undertaking for collective investment in transferable securities (UCITS) with the legal status of an open-ended investment company (SICAV) established under Part I of the Luxembourg Law of 2010 relating to undertakings for collective investment.

Term

The Product does not have a maturity date (the Product has been established for an indefinite period of time). The Manufacturer may terminate the Product early. The amount you will receive upon early termination may be less than the amount you invested. The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

Objectives

The actively managed investment fund invests primarily in equities and other equity shares of smaller companies worldwide. The fund focuses on long-term themes that the portfolio manager considers attractive from an investment perspective, such as digital data, enabling technologies, automation & robotics, security, e-commerce, financial technologies (fintech), health technologies, genetic therapies, clean air & carbon reduction and waste management.

Based on sound analysis from our investment specialists worldwide, the fund manager combines carefully selected stocks of various companies from different countries and sectors with the aim of taking advantage of interesting return opportunities while keeping the risks under control.

The portfolio manager has complete discretion to construct the portfolio and is not bound by the benchmark in terms of equities and weighting.

The investment fund is actively managed in relation to the benchmark MSCI ACWI Small Cap Index (net div. reinvested). The benchmark is used for portfolio composition, performance comparison and risk management purposes.

The investment fund may invest in Chinese A-shares through the Hong Kong-Shanghai Shenzhen Stock Connect (Stock Connect) programme. This sub-fund promotes environmental and/or social characteristics but does not pursue a sustainable investment objective. The return of the fund depends primarily on equity market development and their exchange rate fluctuations, as well as dividend payments.
