What is this product?

Type

UBS (Lux) Equity SICAV is an undertaking for collective investment in transferable securities (UCITS) with the legal status of an open-ended investment company (SICAV) established under Part I of the Luxembourg Law of 2010 relating to undertakings for collective investment.

The Product does not have a maturity date (the Product has been established for an indefinite period of time). The Manufacturer may terminate the Product early. The amount you will receive upon early termination may be less than the amount you invested. The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

Objectives

The actively managed fund invests globally in equity securities and equity rights in developed and emerging markets. The investment fund allocates its assets between a number of innovative, emerging sub-strategies with shorter track records. These substrategies also include sustainable or thematic strategies or strategies with other innovative investment styles. In order to achieve a globally diversified equity allocation, the investment fund may also invest in established strategies with longer track records. The fund uses the benchmark MSCI AC World (net dividend reinvested) for performance comparison, risk management and portfolio construction. The portfolio may deviate from the benchmark in terms of orientation and performance. The return of the fund depends primarily on equity market development and their exchange rate fluctuations, as well as dividend payments. The income from this share class is reinvested (reinvestment).

Intended retail investor

This fund applies to retail investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at growing the investment value, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy medium term investment needs. The fund is only suited to be acquired within a discretionary mandate.
