What is this product?

Type

UBS (Lux) Equity SICAV is an undertaking for collective investment in transferable securities (UCITS) with the legal status of an open-ended investment company (SICAV) established under Part I of the Luxembourg Law of 2010 relating to undertakings for collective investment.

The Product does not have a maturity date (the Product has been established for an indefinite period of time). The Manufacturer may terminate the Product early. The amount you will receive upon early termination may be less than the amount you invested. The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?"

Objectives

The actively managed fund primarily invests globally in shares of companies with a connection to the trend of healthy living and disease prevention

This sub-fund promotes environmental and/or social characteristics but does not have a sustainable investment objective. Working on the basis of well-grounded analyses by our investment specialists worldwide, the fund manager combines carefully selected equities of various companies from various countries and segments with the objective of exploiting interesting earnings opportunities while keeping the level of risk under control.

The sub-fund is actively managed with reference to the benchmark, MSCI World (net div. reinv.). The benchmark is used in portfolio composition, performance comparison and risk management. The portfolio manager may freely choose how to compile the portfolio and is not tied to the benchmark in selecting and weighting equities.

The return of the fund depends primarily on equity market development and their exchange rate fluctuations, as well as dividend payments. The income from this share class is reinvested (reinvestment).

Intended retail investor

This fund applies to retail investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at growing the investment value and addresses a preference for Sustainable Investing, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy medium term investment needs. The fund can be acquired by professional investors and through selected distribution channels only.
