# What is this product?

#### Type

UBS (Lux) Strategy SICAV is an undertaking for collective investment in transferable securities (UCITS) with the legal status of a Fonds Commun de Placement (FCP) established under Part I of the Luxembourg Law of 2010 relating to undertakings for collective investment.

#### Term

The Product does not have a maturity date (the Product has been established for an indefinite period of time). The Manufacturer may terminate the Product early. The amount you will receive upon early termination may be less than the amount you invested. The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

## Objectives

The actively managed sub-fund invests in equities and bonds, including money market instruments. The allocation will vary, but will maintain a strong focus on bonds. The portfolio managers can also use derivatives to achieve the investment fund's investment objective. The investment fund may invest up to 100% of its net assets in investment funds. This sub-fund promotes environmental and/or social features but does not pursue a sustainable investment objective.

The sub-fund invests worldwide on a broadly diversified basis in accordance with the principle of risk diversification. The asset allocation and the specifications of the investment strategies are based on the UBS House View (UBS investment policy).

The sub-fund makes investments without being constrained by a benchmark.

The return of the fund depends primarily on the development of capital markets. To varying degrees, it will be a function of the following components: equity market development and dividend payments, development of interest rates, creditworthiness of the entities issuing the invested instruments and interest income. The return may also be affected by currency fluctuations, where active or unhedged positions exist. This share class is a distributing share class. Distributions can comprise income and capital, and may be paid out exclusive of fees.

## Intended retail investor

This fund applies to retail investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at generating a substantial part of its yield through recurring income and addresses a preference for Sustainable Investing, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy short term investment needs. The fund is suited to be acquired by the target client segments without any restriction of the distribution channel or platform.

#### Costs over time
