## What is this product?

### Type

UBS (Lux) Strategy SICAV is an undertaking for collective investment in transferable securities (UCITS) with the legal status of a Fonds Commun de Placement (FCP) established under Part I of the Luxembourg Law of 2010 relating to undertakings for collective investment.

### Term

The Product does not have a maturity date (the Product has been established for an indefinite period of time). The Manufacturer may terminate the Product early. The amount you will receive upon early termination may be less than the amount you invested.

The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

### Objectives

The investment fund invests in a variable ratio primarily in high-quality bonds, money market instruments and equities worldwide. The proportion of equities can vary greatly and may be as high as 70%. Hedge funds and commodities may also be included to a lesser extent. The fund manager combines carefully selected securities from different asset classes with the objective of taking advantage of interesting return opportunities while controlling risk.

The actively managed mutual fund uses a composite benchmark as a reference for risk management consisting of 8% Bloomberg Eurodollar Corporate AAA-BBB 1-5Y Index, 18% Bloomberg US Corporate Investment Grade Index, 5% ICE BofA US High Yield Constrained Index, 4% J.P. Morgan Emerging Market Bond Index Global Diversified, 50% MSCI World Index (net div. reinvested) (hedged in USD), 5% MSCI Emerging Markets Index (net div. reinvested) (unhedged), 10% HFRX Global Hedge Fund Index. The investment fund is not restricted by a benchmark in its investments.

The benchmark is used for performance comparison.

Sustainability risks are not systematically integrated due to the investment strategy and the nature of the underlying investments.

The return of the fund depends primarily on the development of capital markets. To varying degrees, it will be a function of the following components: equity market development and dividend payments, development of interest rates, creditworthiness of the entities issuing the invested instruments and interest income. The return may also be affected by currency fluctuations, where active or unhedged positions exist.

This share class is a distributing share class. Distributions can comprise income and capital, and may be paid out exclusive of fees. The exchange rate risk of the share class currency is not hedged against the currency of the fund.

### Intended retail investor

This fund applies to retail investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at growing the investment value, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy medium term investment needs. The fund is suited to be acquired by the target client segments without any restriction of the distribution channel or platform.

### What happens if UBS Fund Management (Luxembourg) S.A. is unable to pay out?

In addition, UBS Europe SE, Luxembourg Branch, the depositary of the Fund responsible for safekeeping its assets (the "Depositary"), is subject to a potential default risk in the event that the assets of the Fund held with the Depositary are lost. However, this risk of default is limited as the Custodian is required by law and regulation to segregate its own assets from the Fund's assets. The Custodian shall be liable to the Fund or the Fund's investors for any loss of a financial instrument held in custody by the Custodian or its delegate, unless the Custodian can demonstrate that the loss resulted from an external event beyond its control.

## What are the costs?

### Costs over time
