What is this product?

Type

UBS (Lux) Strategy SICAV is an undertaking for collective investment in transferable securities (UCITS) with the legal status of a Fonds Commun de Placement (FCP) established under Part I of the Luxembourg Law of 2010 relating to undertakings for collective investment.

Term

The Product does not have a maturity date (the Product has been established for an indefinite period of time). The Manufacturer may terminate the Product early. The amount you will receive upon early termination may be less than the amount you invested. The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

Objectives

The investment fund invests in various asset classes with a focus on equities and bonds. The objective is to generate stable and moderate to high returns from interest rates, dividends, option premiums and other sources. The fund manager combines carefully selected stocks from different countries, sectors and companies with the aim of taking advantage of interesting return opportunities while keeping risks under control. The actively managed sub-fund uses a composite benchmark as a reference for risk management purposes comprising 40% MSCI World Index 4% MSCI Emerging Markets Index 4% FTSE EPRA NAREIT Global Index 4% FTSE USD Euro Deposits 3M 4% Bloomberg US Intermediate Corporate Index 13% ICE BofA US High Yield Constrained 1-5y Index 12% ICE BofA US High Yield Master II Constrained Index 4% J.P. Morgan JACI Investment Grade Index 5% J.P. Morgan JACI High Yield Index 5% J.P. Morgan EMBI Global Diversified Index 5% J.P. Morgan GBI EM Global Diversified Index. The sub-fund invests without any benchmark restrictions. The performance of the sub-fund is not benchmarked against an index. The sub-fund does not promote any environmental, social or governance (ESG) characteristics and does not pursue any sustaina-bility or impact objective. Sustainability risks are not systematically integrated on the basis of the investment strategy and the type of underlying investments.

The return of the fund depends primarily on the development of capital markets. To varying degrees, it will be a function of the following components: equity market development and dividend payments, development of interest rates, creditworthiness of the entities issuing the invested instruments and interest income. The return may also be affected by currency fluctuations, where active or unhedged positions exist. This share class is a distributing share class. Distributions can comprise income and capital, and may be paid out exclusive of fees. The exchange rate risk of the share class currency is not hedged against the currency of the fund.

Intended retail investor

This fund applies to retail investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at growing the investment value, with a bias to income-generating assets, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy medium term investment needs. The fund is suited to be acquired by the target client segments without any restriction of the distribution channel or platform.
