What is this product?

Type

UBS (Lux) Key Selection SICAV is an undertaking for collective investment in transferable securities (UCITS) with the legal status of an openended investment company (SICAV) established under Part I of the Luxembourg Law of 2010 relating to undertakings for collective investment.

Term

The Product does not have a maturity date (the Product has been established for an indefinite period of time). The Manufacturer may terminate the Product early. The amount you will receive upon early termination may be less than the amount you invested. The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

Objectives

The objective of this investment fund is to generate income through the active management of a global diversified portfolio. The sub-fund invests in various asset classes with a focus on equities and bonds. The investment fund invests globally in bonds and equities in variable proportions.

The fund manager combines carefully selected securities from different countries, sectors and companies with the aim of taking advantage of interesting return opportunities while keeping risks under control.

The actively managed investment fund uses a composite benchmark as a reference for risk management consisting of 60% MSCI All Country World Index (net div reinvested), (hedged in USD) / 40% Bloomberg Global Aggregate Total Return Index (hedged in USD). The return of the fund depends primarily on the development of capital markets. To varying degrees, it will be a function of the following components: equity market development and dividend payments, development of interest rates, creditworthiness of the entities issuing the invested instruments and interest income. The return may also be affected by currency fluctuations, where active or unhedged positions exist. The income from this share class is reinvested (reinvestment). The exchange rate risk of the share class currency is to a large extent hedged against the currency of the fund.

Intended retail investor

This fund applies to retail investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at growing the investment value, with a bias to income-generating assets, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy medium term investment needs. The fund is suited to be acquired by the target client segments without any restriction of the distribution channel or platform.
