### What is this product?

#### Type

UBS (Lux) Key Selection SICAV is an undertaking for collective investment in transferable securities (UCITS) with the legal status of an openended investment company (SICAV) established under Part I of the Luxembourg Law of 2010 relating to undertakings for collective investment.

The Product does not have a maturity date (the Product has been established for an indefinite period of time). The Manufacturer may terminate the Product early. The amount you will receive upon early termination may be less than the amount you invested. The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

### Objectives

The investment fund invests in equities, bonds and money market instruments worldwide in variable proportions. The proportion of equities can vary greatly and may be up to 175% with leverage, but can also be reduced completely. During periods of high equity exposure, the fund may simultaneously take up to 60% short exposure to bonds.

The fund manager combines carefully selected securities with the aim of taking advantage of interesting return opportunities while keeping risks under control through diversification.

The investments and performance of the investment fund may deviate from the benchmark.

The sub-fund is actively managed in relation to the benchmark MSCI All Country World with Developed Markets (net div. reinvested) (hedged The sub-fund is actively managed in relation to the benchmark MSCLAII Country World with Developed Markets (net div. reinvested) (neuge to USD). The benchmark is used for performance comparison. The investment fund uses a composite benchmark as a reference for risk management consisting of 36% MSCLUSA Index (net div. reinvested), 12% MSCI Emerging Markets Index (net div. reinvested), 23% MSCI EMU Index (net div. reinvested) (hedged to USD), 75% MSCI United Kingdom Index (net div. reinvested) (hedged to USD), 7% MSCI Japan (net div. reinvested) (hedged to USD), 7% MSCI Switzerland (net div. reinvested) (hedged to USD).

Sustainability risks are not systematically integrated due to the investment strategy and the nature of the underlying investments. The return of the fund depends primarily on equity market development and their exchange rate fluctuations, as well as dividend payments.

This share class is a distributing share class. Distributions can comprise income and capital, and may be paid out exclusive of fees. The exchange rate risk of the share class currency is to a large extent hedged against the currency of the fund.

This fund applies to retail investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at growing the investment value, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy medium term investment needs. The fund is only suited to be acquired within a discretionary mandate.

# What happens if UBS Asset Management (Europe) S.A. is unable to pay out?
