## What is this product?

## Type

UBS (Lux) Key Selection SICAV is an undertaking for collective investment in transferable securities (UCITS) with the legal status of an openended investment company (SICAV) established under Part I of the Luxembourg Law of 2010 relating to undertakings for collective investment.

The Product does not have a maturity date (the Product has been established for an indefinite period of time). The Manufacturer may terminate the Product early. The amount you will receive upon early termination may be less than the amount you invested. The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

## Objectives

The actively managed investment fund invests worldwide primarily in equities and other equity shares of small, mid and large-cap companies from developed markets and emerging markets. The fund focuses on digital themes that the portfolio manager considers attractive from an investment perspective, such as e-commerce, security and protection, digital data, enabling technologies, financial technologies (fintech) and

Based on sound analysis from our investment specialists worldwide, the fund manager combines carefully selected securities of various companies from different countries and sectors with the objective of taking advantage of interesting return opportunities while controlling risks.

The portfolio manager has complete discretion to construct the portfolio and is not bound by the benchmark in terms of equities and weighting.

The investment fund is actively managed in relation to the benchmark MSCI AC World (net div. reinvested). The benchmark is used for

portfolio composition, performance comparison and risk management purposes.
The investment fund may invest in Chinese A-shares through the Hong Kong-Shanghai Shenzhen Stock Connect ("Stock Connect") programme.

This sub-fund promotes environmental and/or social characteristics but does not pursue a sustainable investment objective. The return of the fund depends primarily on equity market development and their exchange rate fluctuations, as well as dividend payments. This share class is a distributing share class. Distributions can comprise income and capital, and may be paid out exclusive of fees. The exchange rate risk of the share class currency is to a large extent hedged against the currency of the fund.

## Intended retail investor

This fund applies to retail investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at growing the investment value, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy long term investment needs. The fund is only suited to be acquired within a discretionary mandate.

# What happens if UBS Asset Management (Europe) S.A. is unable to pay out?

#### Costs over time
