What is this product?

UBS (Lux) Key Selection SICAV is an undertaking for collective investment in transferable securities (UCITS) with the legal status of an openended investment company (SICAV) established under Part I of the Luxembourg Law of 2010 relating to undertakings for collective investment.

The Product does not have a maturity date (the Product has been established for an indefinite period of time). The Manufacturer may terminate the Product early. The amount you will receive upon early termination may be less than the amount you invested. The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

The investment objective of the actively managed fund is to generate income and capital gains by investing in a broadly diversified portfolio of bonds, such as government bonds, corporate bonds, emerging market bonds, ABS/MBs and CDOs/CLOs. The sub-fund may invest a total of up to 20% of its net assets in ABS, MBS and CDO/CLO. The fund manager combines carefully selected bonds of various companies from different countries and sectors with the aim of taking

advantage of interesting return opportunities while controlling risks.

The sub-fund is managed without reference to a benchmark. Consequently, the exposure to global bond and currency markets is expected to change over time at the discretion of the Portfolio Manager.

The return of the fund depends primarily on the development of interest rates and creditworthiness of the issuers and the interest income. The return may also be affected by currency fluctuations, where active or unhedged positions exist.

This share class is a distributing share class. Distributions can comprise income and capital, and may be paid out exclusive of fees.

Intended retail investor

This fund applies to retail investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at generating a substantial part of its yield through recurring income, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy short term investment needs. The fund is suited to be acquired by the target client segments without any restriction of the distribution channel or platform.

What happens if UBS Asset Management (Europe) S.A. is unable to pay out?

What are the costs?

Costs over time

The table shows the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. - In the first year you would get back the amount that you invested (0% annual return). For the other holding periods, we have assumed that the product performs as shown in the moderate scenario.
