What is this product?

Type

UBS (Lux) Key Selection SICAV is an undertaking for collective investment in transferable securities (UCITS) with the legal status of an openended investment company (SICAV) established under Part I of the Luxembourg Law of 2010 relating to undertakings for collective investment.

Term

The Product does not have a maturity date (the Product has been established for an indefinite period of time). The Manufacturer may terminate the Product early. The amount you will receive upon early termination may be less than the amount you invested. The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

Objectives

This actively managed fund invests its assets primarily in equities and other equity shares of companies domiciled or operating mainly in Europe. The sub-fund invests primarily in European growth companies that are leaders in their fields, especially in terms of sustainability. The fund uses the benchmark MSCI Europe Growth (net dividend reinvested) as a reference for portfolio construction, performance assessment, for comparison of the sustainability profile and for risk management purposes. Although a portion of the portfolio may be invested in the same instruments and at the same weightings as the benchmark, the Portfolio Manager is not bound by the benchmark when selecting instruments. In times of high market volatility, the performance of the fund may therefore deviate significantly from the benchmark. The portfolio manager may, at its discretion, invest in equities and other investments of small and mid-cap companies and manage market exposure by means of derivatives. This sub-fund promotes environmental and/or social features but does not pursue a sustainable investment objective.

The return of the fund depends primarily on equity market development and their exchange rate fluctuations, as well as dividend payments. The income from this share class is reinvested (reinvestment).

Intended retail investor

This fund applies to retail investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at growing the investment value and addresses a preference for Sustainable Investing, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy medium term investment needs. The fund is only suited to be acquired in a financial advisory context.
