What is this product?

UBS (Lux) Key Selection SICAV is an undertaking for collective investment in transferable securities (UCITS) with the legal status of an openended investment company (SICAV) established under Part I of the Luxembourg Law of 2010 relating to undertakings for collective investment.

The Product does not have a maturity date (the Product has been established for an indefinite period of time). The Manufacturer may terminate the Product early. The amount you will receive upon early termination may be less than the amount you invested. The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

The sub-fund invests in a diversified portfolio of mainly subordinated debt securities (including hybrid bonds (regulatory capital securities that financial institutions issue that are perpetual and could stay outstanding beyond their first call date) such as Additional Tier 1 securities) of the financial credit sector in Europe. The sub-fund may invest up to 40% of its net assets in contingent convertible bonds (CoCos). This sub-fund promotes environmental and/or social characteristics but does not have a sustainable investment objective

The sub-fund uses the benchmark Bloomberg Euro Credit Corp Sub Financials 2% Cap (128366EU) as a reference for portfolio construction,

performance evaluation, sustainability profile comparison and for risk management purposes.

Although part of the portfolio is invested in the same instruments and with the same weightings as the benchmark, the portfolio manager is

not tied to the benchmark in selecting instruments. In particular, the portfolio manager may freely choose to invest in bonds of issuers that are not included in the benchmark and/or set a different sector allocation to the weighting in the benchmark, in order to seize investment opportunities. At times of high market volatility, the fund's performance may therefore diverge significantly from that of the benchmark. The return of the fund depends primarily on the development of interest rates and creditworthiness of the issuers and the interest income. The return may also be affected by currency fluctuations, where active or unhedged positions exist.

The income from this share class is reinvested (reinvestment).

Intended retail investor

This fund applies to retail investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at growing the investment value and addresses a preference for Sustainable Investing, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy short term investment needs. The fund can be acquired by professional investors and through selected distribution channels only.

The Custodian shall be liable to the Fund or the Fund's investors for any loss of a financial instrument held in custody by the Custodian or its delegate, unless the Custodian can demonstrate that the loss resulted from an external event beyond its control

What are the costs?
