What is this product?

Type

UBS (Lux) Key Selection SICAV is an undertaking for collective investment in transferable securities (UCITS) with the legal status of an openended investment company (SICAV) established under Part I of the Luxembourg Law of 2010 relating to undertakings for collective investment.

The Product does not have a maturity date (the Product has been established for an indefinite period of time). The Manufacturer may terminate the Product early. The amount you will receive upon early termination may be less than the amount you invested. The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

Objectives

This actively managed fund aims to invest in equities and other equity interests of companies in developed markets worldwide on the basis of a value approach. The fund uses the benchmark MSCI World (net div. reinvested) for performance comparison, risk management and for portfolio construction. This sub-fund promotes environmental and/or social characteristics but does not have a sustainable investment

The return of the fund depends primarily on equity market development and dividend payments.

The income from this share class is reinvested (reinvestment).

Intended retail investor

This fund applies to retail investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at growing the investment value, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy medium term investment needs. The fund can be acquired by professional investors and through selected distribution channels only.
