What is this product?

Type

UBS (CH) Global Alpha Strategies is a contractual investment fund under Swiss law of the type "Other funds for traditional investments" pursuant to the Swiss Federal Act on Collective Investment Schemes (CISA) of 23 June 2006.

Term

This product does not have a maturity date (in other words, it is open-ended). The manufacturer may terminate the product early. The amount you would receive if such early termination took place might be lower than the amount you invested.

The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

Objectives

The investment fund invests in hedge funds worldwide. The diversified fund consists of a number of funds managed by various hedge fund managers with different investment approaches. The fund can invest a large share of its assets in risk-bearing investments, and as such may experience large fluctuations in value. The fund's return depends primarily on the performance of alternative investments via its fund of hedge funds exposure. The return may also be affected by currency fluctuations where active or unhedged positions exist.

This share class is a distributing share class. The share class may pay dividends. The exchange rate risk of the share class currency is to a large extent hedged against the currency of the fund.

Intended retail investor

This fund applies to retail investors with an advanced financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at growing the investment value, while requiring acceptance of certain restrictions to accessing the capital. With their investment in this fund, investors can satisfy medium term investment needs. The fund is only suited to be acquired within a discretionary mandate.

What happens if UBS Fund Management (Switzerland) AG is unable to pay out?

In addition, in relation to UBS Switzerland AG, which as the Fund's custodian is responsible for the safekeeping of its assets (the "Custodian"), there is a potential risk of default in the event that the Fund's assets held with the Custodian are lost. What are the costs?
