What is this product?

Type

UBS (Lux) SICAV 1 is an undertaking for collective investment in transferable securities (UCITS) with the legal status of an open-ended investment company (SICAV) established under Part I of the Luxembourg Law of 2010 relating to undertakings for collective investment.

Term

The Product does not have a maturity date (the Product has been established for an indefinite period of time). The Manufacturer may terminate the Product early. The amount you will receive upon early termination may be less than the amount you invested.

The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

Objectives

The investment fund invests worldwide, primarily in bond and equity markets, as well as in real estate companies and indirectly in commodities. The fund is oriented to the current phase of the economic cycle in each case. The objective of this investment fund is to avoid extreme fluctuations in value to the greatest extent possible. Consequently, investments in different asset classes are combined in such a way that the return or risk contributions of individual asset classes do not dominate at any stage of an economic cycle.

The fund manager combines carefully selected securities from different countries, sectors and companies with the objective of taking advantage of interesting return opportunities while controlling risks.

The actively managed investment fund uses a composite benchmark as a reference for risk management consisting of 40% MSCI All Country World Index (net div reinv.) denominated (unhedged) in USD/60% FTSE World Government Bond Index (hedged in USD).

Sustainability risks are not systematically integrated due to the investment strategy and the nature of the underlying investments.

The return of the fund depends primarily on the development of capital markets. To varying degrees, it will be a function of the following components: equity market development and dividend payments, development of interest rates, creditworthiness of the entities issuing the invested instruments and interest income. The return may also be affected by currency fluctuations, where active or unhedged positions exist.

The income from this share class is reinvested (reinvestment). The exchange rate risk of the share class currency is to a large extent hedged against the currency of the fund.

Intended retail investor

This fund applies to retail investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at growing the investment value, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy short term investment needs. The fund is suited to be acquired by the target client segments without any restriction of the distribution channel or platform.

What happens if UBS Fund Management (Luxembourg) S.A. is unable to pay out?

In addition, UBS Europe SE, Luxembourg Branch, the depositary of the Fund responsible for safekeeping its assets (the "Depositary"), is subject to a potential default risk in the event that the assets of the Fund held with the Depositary are lost. However, this risk of default is limited as the Custodian is required by law and regulation to segregate its own assets from the Fund's assets. The Custodian shall be liable to the Fund or the Fund's investors for any loss of a financial instrument held in custody by the Custodian or its delegate, unless the Custodian can demonstrate that the loss resulted from an external event beyond its control.

What are the costs?

Costs over time
