What is this product?

Type

UBS (CH) Equity Fund is a contractually-based investment fund under Swiss law with multiple sub-funds (umbrella fund) of the "Other funds for traditional investments" category of the Swiss Federal Act on Collective Investment Schemes of 23 June 2006.

Term

The fund invests in attractive US companies that have an adequate ESG (environmental, social and responsible corporate governance) profile. The fund manager combines carefully selected stocks from various companies from different sectors, based on in-depth analyses by our local investment specialists, with the aim of exploiting interesting earnings opportunities while keeping risks under control. UBS Asset Management classifies this investment fund as Sustainability Focus Fund that promotes ecological and/or social characteristics. The

investment fund uses the benchmark S&P 500 (net dividends reinvested) for portfolio composition, performance comparison, to control the ESG profile and risk management.

The return of the fund depends primarily on the development of the stock markets and dividend payments.

The collective investment scheme's net income is distributed annually to investors within four months at most of the end of the accounting year

Intended retail investor

This fund applies to retail investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at growing the investment value and addresses a preference for Sustainable Investing, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy medium term investment needs. The fund is only suited to be acquired within a discretionary mandate.
