## What is this product?

### Type

UBS (CH) Equity Fund is a contractually-based investment fund under Swiss law with multiple sub-funds (umbrella fund) of the "Other funds for traditional investments" category of the Swiss Federal Act on Collective Investment Schemes of 23 June 2006.

#### Term

This product does not have a maturity date (in other words, it is open-ended). The manufacturer may terminate the product early. The amount you would receive if such early termination took place might be lower than the amount you invested.

The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

## Objectives

The investment fund mainly invests in shares of Swiss companies.

The aim of the investment strategy is an above-average equity return compared to the return on the Swiss stock market. Equity return may come from dividends, call option premiums and other sources. The investments of this actively managed fund are widely diversified across various sectors. The portfolio manager's investment decisions are based on thorough analyses and a systematic investment process and are made at his own discretion but within the specified investment restrictions.

The fund's return depends primarily on the development of the stock markets, exchange rate fluctuations and dividend payments. The collective investment scheme's net income is distributed annually to investors within four months at most of the end of the accounting year.

## Intended retail investor

This fund applies to retail investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at growing the investment value, with a bias to income-generating assets, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy medium term investment needs. The fund is suited to be acquired by the target client segments without any restriction of the distribution channel or platform.

# What happens if UBS Fund Management (Switzerland) AG is unable to pay out?

#### What are the costs?
