#### What is this product?

# Type

UBS (CH) Equity Fund is a contractually-based investment fund under Swiss law with multiple sub-funds (umbrella fund) of the "Other funds for traditional investments" category of the Swiss Federal Act on Collective Investment Schemes of 23 June 2006.

#### Term

This product does not have a maturity date (in other words, it is open-ended). The manufacturer may terminate the product early. The amount you would receive if such early termination took place might be lower than the amount you invested.

The investment fund mainly invests in shares of Swiss companies.

The fund manager invests the fund's assets as a result of an investment process based on quantitative financial models. Stock selection is based on the signals calculated by the quantitative model. This model is constantly being further developed.

The fund manager aims to achieve an above-average sustainability profile compared to standard stock market indices. The investment fund can exclude companies or industries whose products or business activities have a negative social or ecological impact.

UBS Asset Management classifies this investment fund as a Sustainability Focus Fund, which promotes ecological and/or social characteristics. The investment fund uses the benchmark MSCI Switzerland Net Return Index in CHF for portfolio composition, performance comparison, to control the ESG profile and risk management.

The return of the fund depends primarily on the development of the stock markets and dividend payments.

The income from this share class is reinvested (reinvestment).

# Intended retail investor

This fund applies to retail investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at growing the investment value and addresses a preference for Sustainable Investing, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy medium term investment needs. The fund is only suited to be acquired within a discretionary mandate.

# What are the costs?
