What is this product?

Type

Under the name VVA, a contractually-based umbrella fund of the "Other funds for traditional investments" category (the "Umbrella Fund") is established within the meaning of Art. 25 ff. in conjunction with Art. 68 ff. in conjunction with Art. 92 f. of the Federal Act on Collective Investment Schemes of 23 June 2006 (CISA)

Term

This product does not have a maturity date (in other words, it is open-ended). The manufacturer may terminate the product early. The amount you would receive if such early termination took place might be lower than the amount you invested.

The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

Objectives

The fund's primary investment objective is to achieve the largest return on investment possible. It does this by investing at its own discretion but within the prescribed investment restrictions in money market instruments, fixed and floating-rate securities and related derivatives. The fund's overall risk is roughly in line with that of a portfolio of CHF-denominated fixed income investments.

Investments are made in the currencies that are most advantageous for the fund's performance.

Investments can be made all around the world, with the currency risk kept low.

The investment instruments are chosen based on their expected return net of taxes/charges.

This fund is suitable as a module that adds an element missing from a UBS wealth management mandate.

It helps UBS's investment strategy to be implemented efficiently and cost-effectively and to ensure that investments are broadly diversified.

The fund's return depends primarily on interest rates, issuer creditworthiness and interest income. The return may also be affected by currency fluctuations where active or unhedged positions exist.

The collective investment scheme's net income is distributed annually to investors within four months at most of the end of the accounting year. The exchange rate risk of the share class currency is to a large extent hedged against the currency of the fund.

Intended retail investor

This fund applies to retail investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at generating a substantial part of its yield through recurring income, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy medium term investment needs. The fund is only suited to be acquired within a discretionary mandate.

What happens if UBS Fund Management (Switzerland) AG is unable to pay out?

What are the costs?

Costs over time

The table shows the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods, we have assumed that the product performs as shown in the moderate scenario.

Recommended holding period: 4 Year(s)
