## What is this product?

## Туре

UBS 100 Index-Fund Switzerland (CHF) is an investment fund under Swiss law of the type "Other funds for traditional investments" pursuant to the Swiss Federal Act on Collective Investment Schemes (CISA) of 23 June 2006.

## Term

This product does not have a maturity date (in other words, it is open-ended). The manufacturer may terminate the product early. The amount you would receive if such early termination took place might be lower than the amount you invested. The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

## Objectives

The investment fund invests efficiently in shares of the UBS 100 Index, which comprises the 100 largest listed Swiss companies, with the aim of tracking the index.

The fund's return depends primarily on the development of the stock markets and the dividend payments.

The collective investment scheme's net income is distributed annually to investors within four months at most of the end of the accounting year.

## Intended retail investor

This fund applies to retail investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at growing the investment value, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy medium term investment needs. The fund is only suited to be acquired within a discretionary mandate.

# What happens if UBS Fund Management (Switzerland) AG is unable to pay out?

# What are the costs?
