What is this product?

Type

UBS ETF (CH) is a contractual umbrella fund under Swiss law of the type "Other funds for traditional investments" pursuant to the Swiss Federal Act on Collective Investment Schemes (CISA) of 23 June 2006.

Term

This product does not have a maturity date (in other words, it is open-ended). The manufacturer may terminate the product early. The amount you would receive if such early termination took place might be lower than the amount you invested.

The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

Objectives

The investment objective of the subfund is to replicate the price and return performance of the MSCI Switzerland IMI High Dividend Yield ESG Low Carbon Select gross of fees. This sub-fund invests in equities of companies that are already or are going to be included in the MSCI Switzerland IMI High Dividend Yield ESG Low Carbon Select index and in other assets that are permitted under the fund contract. In general, the sub-fund seeks to match the performance of the MSCI Switzerland IMI High Dividend Yield ESG Low Carbon Select.

The sub-fund physically replicates the index and seeks to hold all the securities contained in the index (full index replication). In order to replicate the index, the sub-fund holds a portfolio of securities that contains all or almost all of those included in the underlying index. The sub-fund can invest in all securities included in its reference index in proportion to their index weighting. This sub-fund promotes environmental and/or social characteristics but does not pursue a sustainable investment objective. The fund does not enter into any securities lending.

The fund's return depends primarily on the performance of the index that it replicates.

The sub-fund's net income is distributed annually to investors within four months at most of the end of the accounting year. The fund management company may also make interim distributions from the income.

Intended retail investor

This fund applies to retail investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at growing the investment value and addresses a preference for Sustainable Investing, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy medium term investment needs. The fund is suited to be acquired by the target client segments without any restriction of the distribution channel or platform.

What happens if UBS Fund Management (Switzerland) AG is unable to pay out?
