What is this product?

Migros Bank (Lux) Fund was established on 21 June 2006 under the name Mi-Fonds (Lux) as an open-ended investment fund under the legal form of a self-managed "Société d'Investissement à Capital Variable" (SICAV) and is subject to Part I of the Law of 2010. The Company is registered with the Luxembourg Trade and Companies Register under number B 117.264.

Term

The Product does not have a maturity date (the Product has been established for an indefinite period of time). The Manufacturer may terminate the Product early. The amount you will receive upon early termination may be less than the amount you invested.

Objectives

The fund invests in an internationally diversified portfolio with a focus on investments in CHF, composed of fixed or floating-rate securities on the capital market, convertible bonds and bonds with warrants, as well as equity or other equity securities of companies with good credit ratings. In the long term, up to 50 percent is invested in equities. The proportion of money market investments is 5 percent over the long term (a maximum of 20 percent is permitted). The investment objective is to achieve an above-average and steady return in CHF while maintaining balanced risk diversification as well as optimal liquidity. The actively managed fund uses a composite benchmark for performance comparison and portfolio construction. This is composed as follows: 20% Swiss Performance Index (SPI), 12% MSCI Nordamerika (NDDUNA), 3.5% MSCI Pazifik (NDUEACAP), 12% MSCI Europe ex Switzerland (NDDUEXSZ), 2.5% MSCI Emerging Markets (NDUEGF), 40% SBI Foreign Rating AAA-BBB TR (SBF14T) and 1.25% FTSE US Government Bond Index (SBUSL), 0.5% FTSE Japan Government Bond Index (SBJYL), 3.25% FTSE EMU Government Bond Index (SBEGEU) and 5% FTSE CHF 1 Month (SBWMSF1L). The majority of the fund's investments will be part of the benchmark and have a similar weighting to it. Although the portfolio at its own discretion and is not bound to the benchmark in terms of investments and weightings. In particular, the asset manager may, at its discretion, invest in securities of issuers that are not included in the benchmark. The portfolio may therefore deviate from the benchmark in terms of orientation and performance. In addition, it may decide to deviate from the benchmark in terms of sector weighting in order to benefit from investment opportunities.

The fund's return depends primarily on the performance of the capital markets. The following factors play a role to varying degrees: Development of the stock markets and dividend payments, interest rates, creditworthiness of the issuers of the invested instruments and interest income. Returns may also be affected by exchange rate fluctuations where there are active or unhedged positions

This share class is a distributing share class. The share class may pay dividends.

Intended retail investor

This fund applies to retail investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at growing the investment value, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy medium term investment needs. The fund is suited to be acquired by the target client segments without any restriction of the distribution channel or platform.



What are the risks and what could I get in return?

Risk indicator



This risk indicator is based on the assumption that you hold the product for 4 year(s).

The Summary Risk Indicator (SRI) is a guide to the level of risk of this product compared to other products. It is derived from past returns and may indicate how likely it is that the product will lose money as a result of future (unknown) market conditions. The Summary Risk indicator (SRI) for this product is 3 out of 7, which is a medium-low risk class.

What are the costs?
