## What is this product?

### Type

PF (the "umbrella fund") is a contractual umbrella fund of the type "Other funds for traditional investments" pursuant to Art. 25 et seq. in conjunction with Art. 68 et seq. and Art. 92 et seq. of the Federal Act on Collective Investment Schemes (CISA) of 23 June 2006.

### Term

This product does not have a maturity date (in other words, it is open-ended). The manufacturer may terminate the product early. The amount you would receive if such early termination took place might be lower than the amount you invested.

The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

### Objectives

The PF - Global Climate Equity Fund invests primarily in units of collective investment schemes that invest in equities worldwide. The investment objective of this sub-fund, which is categorised as a rule-based climate aware strategic fund that is aiming to achieve net zero, is primarily to generate a long-term performance in line with the performance of the standard market indices for global equity investments in developed markets.

The fund's income remains in the fund (reinvestment).

### Intended retail investor

This investment fund is suitable for private investors with no or limited investment experience who are able to bear potential investment losses. This investment fund aims to increase in value and to allow daily access to invested capital under normal market conditions. It satisfies medium-term investment requirements and can only be acquired by professional investors.

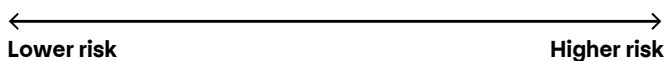

## What are the risks and what could I get in return?

### Indicator



The risk indicator assumes you keep the product for 9 years.

### What happens if UBS Fund Management (Switzerland) AG is unable to pay out?

## What are the costs?

### Costs over time

The table shows the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods, we have assumed that the product performs as shown in the moderate scenario.
- 10 000 CHF is invested.
